- Executive Director Report
  - Spoke with

    - County Executive Staff
      - Due Diligence
      - Discussed transferring some County owned properties to the Land Bank
    - CRC/NCST
      - 7 East Dewey, East Rockaway
        - o Still in foreclosure process
      - 2 Additional Properties
        - o East Meadow (in foreclosure); not torn down
        - o 54 Powell St., Roosevelt (in foreclosure)
      - Other Properties
        - o 26 Anchor Street, Freeport
          - Confirming w/ Village if we can build on the property
        - Merrick Property
          - No street access
          - Confirming with the ToH about building on the land
        - o Roosevelt Site
        - Inwood Site
        - Elm Ave., Hempstead (2 lots)
          - Both are buildable
  - Next Steps
    - Drafted RFP for architecture services
      - Will be sent out shortly
    - Siela Bynoe brought up the County RFP process and whether or not the Land Bank wants to follow their procedure
      - Maybe the Land Bank should put out its own RFP (easier/quicker)
    - When RFP is ready, the LB will notify Newsday, other Land Banks and the Land Bank Association, DCA's, LIHP, etc.
    - Looking at a "phase 1" RFP as well
      - Suffolk County Land Bank has a "phase 1 RFP" scope
      - The Suffolk County Land Bank has a unique agreement w/ the State shifting liability on brownfields

- Will include the phase 1 RFP in the emails/notice sent out to the various
- organizations/agencies
- Will ask DPW if they have a Phase 1 contractor
- Elmont Property
  - Demolition
    - Request to PSEG< Water, National Grid to discontinue services
    - Just waiting on their confirmations letters
    - Asked Water Authority to waive fee (as the LB is a 501(c)3)
    - Will follow up w/ PSEG/National Grid's service reps
    - The LB is in agreement that it will mail out a check to the Water Authority ASAP
- Grant Funding
  - Tanya from Enterprise said we will get an extension on spending through the year
  - Application process for the next round of grants to begin in the Fall
  - Need to include what project we have on the horizon
- Land Bank Business
  - Vice Chair Meredith Hughes suggested the LB look into three properties
    - 75 Thorman Ave., Hicksville (tax distressed property possessing a lien)
    - 3 Clarissa Dr., Hicksville
    - 153 N. Maple St., Massapequa
  - o Still working on getting Executive Director Brittney Russell on all bank accounts
    - If no resolution, call Beamont Jefferson to give his government contact at the banks
