A LOCAL LAW TO AMEND TITLE 79-a OF THE MISCELLANEOUS LAWS OF NASSAU COUNTY TO PROVIDE RELIEF FROM FEES CHARGED BY VARIOUS DEPARTMENTS OF COUNTY GOVERNMENT TO THE VICTIMS OF SUPERSTORM SANDY

Became a law on January 29, 2020 with the approval of the Deputy County Executive acting on behalf of the County Executive.

BE IT ENACTED, by the County Legislature of the County of Nassau, as follows:

- Section 1. Subdivision (e) of Section 3 of Title 79-a FEE RELIEF FOR HURRICANE/SUPER STORM SANDY VICTIMS of the Miscellaneous Laws of Nassau County is amended as follows:
- (e) The refund or waiver authorized by this Local Law shall apply to applicants so long as they show good cause as defined by § 3(a), above.
- §2. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its application to the person or circumstance directly involved in the controversy in which such order or judgment shall be rendered.
- §3. SEQRA Determination. This Legislature, being the State Environmental Quality Review Act (SEQRA) lead agency, hereby finds and determines that this action is an unlisted action under the provisions of Title 6 NYCRR Part 617, and that based on an evaluation of the environmental criteria set forth in §617.7(c) that are considered to be indicia of significant adverse environmental

impacts, along with the recommendation of the Nassau County Planning Commission acting in its advisory capacity to the Legislature, that such action will not have significant adverse impacts on the environment, and that no additional environmental review or action is necessary.

§4. Effective date. This law shall take effect immediately.
