- 4 tobacco retailers and vendors in Nassau
- 5 County to ensure compliance with New York
- 6 State law.

- 15 Legislature, pass the Smoking 21.
- People ask me about it all the
- 17 time and I really never have a good answer
- 18 as to why it's not called. But we're really
- 19 lagging behind the counties around us.
- I can't think of a better tribute
- 21 to Judy then to at least having that
- 22 discussed. So if there is any way the
- 23 Health Committee, especially you, Rose, as
- 24 the chairwoman, could bring that up, we
- 25 would love to have at least a hearing on it.

- 19 with the other counties would really make
- 20 sense. Thank you.
