Addendum to Application for License or Permit

Issuance of a Nassau County Fire Marshal Permit to Install or Remove Tanks, is predicated on the agreement to conform to the following requirements:

- 1. The Trade/Craft License requirements of all Towns, Incorporated Villages, or other political subdivision, or the requirements of any other agency having jurisdiction must be complied with.
- 2. All piping shall be installed in accordance with the requirements of Article III of the Nassau County Fire Prevention Ordinance, Standard 30 of the National Fire Protection Association and local building codes, and manufacturers current instructions and specifications.
- 3. All tank installations shall be done in accordance with the requirements of Article III, of the Nassau County Fire Prevention Ordinance, Standard 30 of the National Fire Protection Association and local building codes.
- 4. The design, fabrication and construction of tanks shall comply with the provisions of Chapter 2 of Standard National Fire Protection Association No. 30-1990, The Flammable and Combustible Liquids Code.
- 5. All piping, valves and fittings shall comply with Chapter 3 of Standard National Fire Protection Association No. 30-1990, The Flammable and Combustible Liquids Code.
- 6. All tanks are to be installed as per the manufacturer's current instructions and specifications.
 - A. A copy of the manufacturer's current installation requirements and specifications must be on the job site during tank installation.
 - B. Tank Manufacturer's Certification: If a tank manufacturer certifies installers of its spe cific product, only firms or individuals holding a current manufacturer's certification card will be permitted to install said tank(s). Such person, firm, or corporation must also have the required Nassau County permit.
 - C. The serial number(s) of the tank(s) shall be noted and recorded on the drawings ap proved by this office. (On appropriate tank)
 - D. The Fire Marshal's Office shall be notified by the contractor of the start date of the tank installation.

7. Approved Drawings:

- A. Approved drawings/plans must be on the site during tank and/or piping installation.
- B. If tank(s) installation location, piping runs, etc. deviate from the approved plans, revised plans shall be submitted for review and approval prior to installation. If changes not considered to be a major deviation from the approved plans are contemplated or necessary, this office shall be informed of the proposed changes and either revised plans or "as Built" plans shall be submitted so that the change of installation is reflected.

8. Liner Installation:

- A. This office shall be notified when a liner is in place.
- B. Only approved liner material shall be used. (liner specifications from the manufacturer denoting type, style, number, etc. shall be on the job site during installation.
- 9. Coated Steel Tanks:
 - A. This office shall be notified when the tanks are delivered to the site.
 - B. Only coated steel tanks approved by this office shall be installed.
 - C. Spark test results shall be supplied with the tank and made available for inspection.
- 10. The use of a temporary holding tank is **PROHIBITED** during new tank installation, unless it conforms to the requirements of this office.
- 11. Tank Abandonment or Removal shall be performed in accordance with Article III of the Nassau County Fire Prevention Ordinance and 6NYCRR Part 613.
- 12. Tank Abandonment shall be scheduled with the Fire Marshal.
