NCDPW will conduct a formal public hearing on **Thursday**, **February 16**, **2017**. There will be a morning session starting at 11AM at the following location: Theodore Roosevelt Executive & Legislative Building, 1550 Franklin Avenue, (Main Floor), Mineola, NY.

NCDPW will accept comments on the DGEIS until close of business, March 17, 2017. Written comments can be delivered by mail or e-mail to the NCDPW address listed below at the end of this Notice.

Description of Action:

Through the Mosquito Control Plan (MCP), the Nassau County Department of Public Works (NCDPW) and Department of Health (NCDOH) work together to suppress mosquito populations that can impact public health (e.g. West Nile Virus, Zika Virus). To achieve this goal, the County's MCP employs Integrated Pest Management (IPM) by focusing on long-term suppression or prevention, with a minimal impact on health, environment, and non-target organisms. IPM incorporates all reasonable measures to prevent mosquito problems by properly identifying species, monitoring population dynamics, and using physical, biological, or chemical population control methods to reduce mosquitoes to acceptable levels. Control measures emphasize prevention and proceed from the most environmentally friendly measures such as education of residents, water management and trapping in detention ponds and sumps, to chemical controls including the application of larvicides and adulticides. Chemical controls are only used if other measures prove to be insufficient.
