- This will be a competition for **vocal talent only**, limited to the first 120 applications received and postmarked on or before July 1, 2008.
- Contestants will be chosen on a first-come, first-served basis and will be notified of audition date by telephone. If applicant cannot be reached by phone, or no response to voice messages is received within 48 hours, applicant will be disqualified.
- Applicants must be available for: Auditions (July 16 & 23), Dress Rehearsal (Aug. 5), Dress Rehearsal rain date (Aug. 6), Finals (Aug. 8) Finals rain date (Aug. 13). There will be no exceptions. Persons who cannot commit to all of these dates should not apply.
- Applications must be accompanied by photocopies of the following:
 - Proof of Age (must be at least 13 but not older than 19 years of age on Finals Date: 8/8/08)
 - Proof of Nassau County residency
 - Photo IDOne form of ID may satisfy all requirements, i.e. Driver's License. Original ID must be presented at audition. For groups, separate application and proof copies must be submitted for each performer.
- **For audition, only accapella performances will be permitted.** For finals, contestant may be accompanied by either single instrumentalist (piano available at theatre), or recorded music on CD or cassette. No accompanying vocal tracks will be permitted on recorded music. Contestants chosen as finalists must submit accompanying recorded music prior to dress rehearsal.
- Nassau County Lakeside Theatre is not responsible for any playback failures during dress rehearsal and final competition. Duplicate CDs or cassettes are recommended.
- Judges reserve the right to disqualify any contestant for use of profane, vulgar or abusive language or action.

I, the undersigned, intending to be legally bound, hereby, for myself, my heirs, executors and administrators waive and release any and all rights and claims for damages I may have against the County of Nassau and their representatives, successors and assigns for any and all injuries, physical or otherwise, suffered by me in said event. If signed by a parent, the parent agrees to release and hold the above named organizations and personnel harmless from any claims and rights which may be asserted on behalf of the participant(s).
