- ❖ PHOTOGRAPHY IS LIMITED TO THE BRIDAL PARTY AND IMMEDIATE FAMILY ONLY.
- ❖ NO TENTS OR CANOPIES MAY BE ERECTED.
- ❖ VEHICLE(S) ARE NOT PERMITTED ON SERVICE ROADS AND MUST BE PARKED IN PARKING LOTS.
- ❖ THERE CAN BE NO RESERVATIONS OF ANY PARTICULAR AREA.
- ❖ PHOTOGRAPHY CANNOT TAKE PLACE BEFORE 10:00 A.M. OR AFTER DUSK.
- ❖ PERMIT IS RAIN OR SHINE.
- ❖ A LEISURE PASSPORT AND/OR APPROVED PERMIT MUST BE PRESENTED AT PARK FACILITY, UPON REQUEST.
- ❖ PERMIT COVERS WEDDING PHOTOGRAPHS ONLY.
