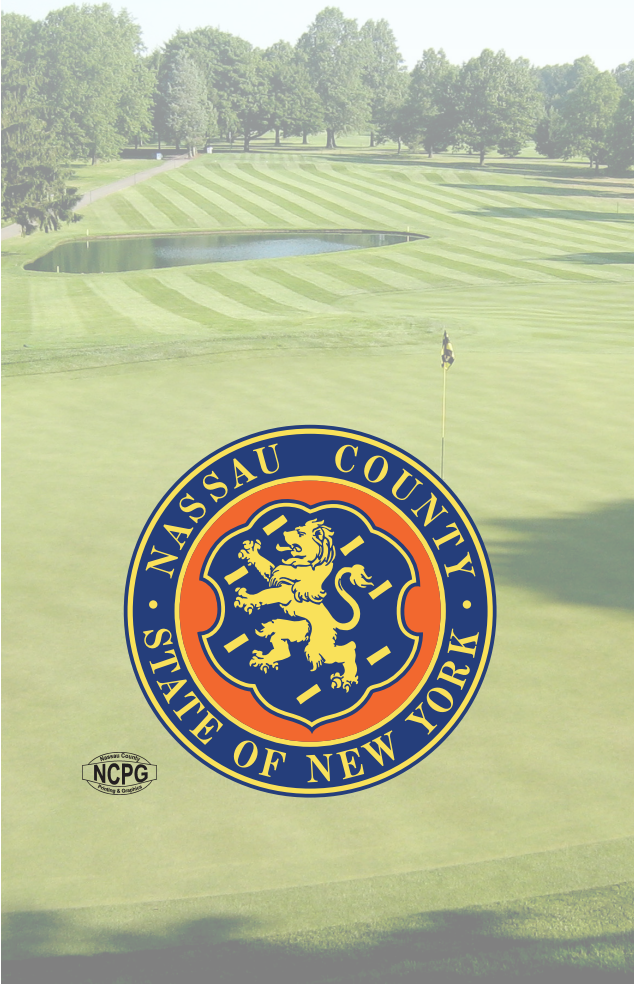

18-Hole Courses

At Eisenhower Park, three of Long Island's finest 18-hole golf courses are open to the public, including the famed "Red" course. The Red Course has a storied history, having been designed by prominent golf architect Devereux Emmet in 1914 and having hosted PGA championships as far back as 1926. A second championship-level course, the White, was designed by Robert Trent Jones, a major 20th-century architect of American courses. Jones also designed the third 18-hole course at Eisenhower, the Blue.

Red Course: Yardage (range, three tees), 7,107 - 5,470; Par 72

White Course: Yardage, 6,932 - 5,357; Par 72

Blue Course: Yardage, 6,409 - 4,891; Par 72

Driving Ranges:

The County provides three driving ranges, open year-round as weather allows.

Cantiague Park: 35 bays, including heated and covered stalls, with a range of 270 yards to the far fence.

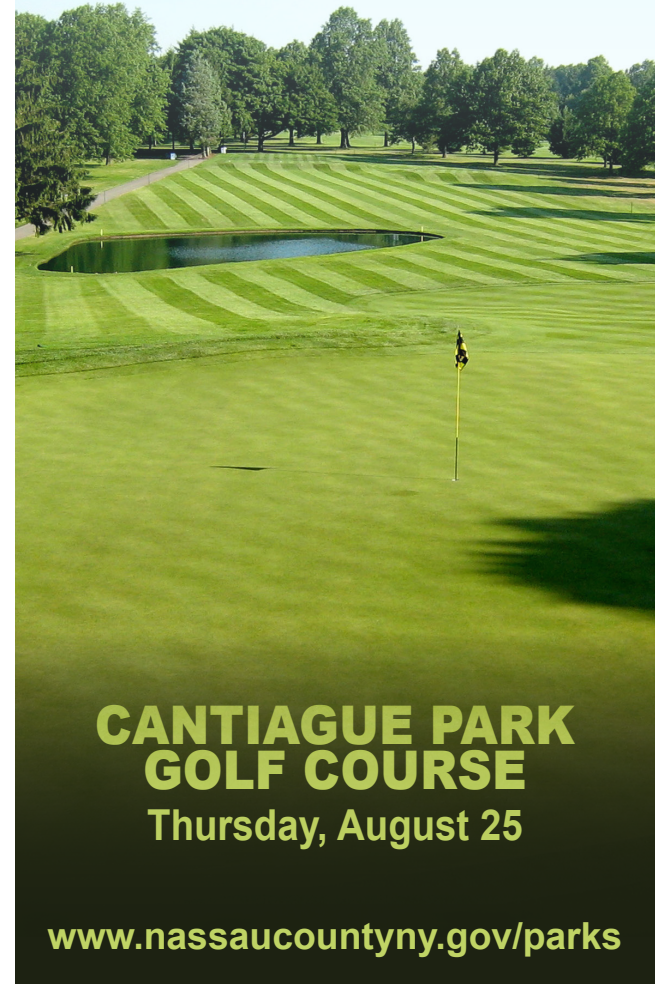
North Woodmere: 22 bays with a range of 175 yards to the far fence.

Nassau County Golf Courses

Nassau County's golf operations are among the most extensive of any municipality in the Northeast, consisting of three 18-hole courses, four nine-holes and three driving ranges. The executive-level nine-hole golf courses, some of which will host the Mixed Couples Twilight Golf Tournament, are conveniently located throughout the county.

Nine-Hole Courses

Cantiague Park This 1,878-yard, par-30 course is open and easy to walk, with five holes of 200 yards or more (the longest is 272 yards).

Location: Hicksville, W. John Street east of Cantiague Rock Road

Bay Park This 1,956-yard, par-30 course is located on the South Shore by the water, with slight terrain and two holes over 300 yards.

Christopher Morley Park This 1,603-yard, par-30 course is the smallest of the nine-hole courses, with the shortest hole being 97 yards and the longest 300 yards. The course provides a hilly, attractive setting in this pretty tree-lined North Shore park.

North Woodmere Park This 2,282-yard, par-31 course is the largest of the nine holes, with four holes over 300 yards (390 and 395 yards for the first and second holes, respectively).

Tournament Details

How to sign up: Complete entry form and mail to: **Cantiague Park; Golf Ticket Office; 490 W. John Street, Hicksville, NY 11801; Attn: Twilight Committee.** Include a copy of Leisure Pass and a check made out to "Treasurer of Nassau County." You must be a Nassau County resident.

Entry fee: \$50 per person, walking; \$60 with cart (carts limited, first-come, first-serve). Fee includes golf, barbecue and prizes.

Format: Each tournament will consist of four-person "scramble" teams. Two couples can sign up as a four-person team or a couple can sign as a two-person team that the tournament committee will pair with another couple. In addition, individuals can sign up and will be paired with other individual players by the tournament committee.

Time: The tournament will be a 4 p.m. shotgun, with a 3 p.m. check-in and the barbecue and awards ceremony from 6 - 8 p.m. *Rain dates announced and determined by tournament committee.*
