## NEW Legal Information Program Launched in Partnership with the Long Island Hispanic Bar Association (LIHBA)

As part of its mission to serve the community, the Nassau County Office of Hispanic Affairs launched a new Legal Information Program in partnership with the Long Island Hispanic Bar Association (LIHBA). This program provides Nassau County residents a no cost, confidential consultation with a LIHBA bi-lingual volunteer attorney for legal information. The goal of this partnership is to ensure that Spanish speaking residents in need of legal information and resources can easily speak with a volunteer attorney for information. The Office of Hispanic Affairs works with constituents in completing a confidential intake form and a LIHBA volunteer attorney will then contact the constituent for a confidential consultation. This partnership provides constituents access to relevant and accurate information. \*

In efforts of furthering our mission, the Nassau County Office of Hispanic Affairs hosted a variety of educational workshops, both virtually and in-person throughout the year. In person events included an educational forum on heart health and healthy eating with Mt. Sinai which also included blood pressure screenings at no cost to participants. A bilingual information session with PSEG LI and National Grid on financial assistance programs. A bilingual Census workshop on the importance of being counted in the Census, and available employment opportunities.

During the pandemic our office had to adjust to the "new normal" by expanding our educational programming via our virtual platform. This included participating in a webinar with the Long Island Hispanic Chamber of Commerce to inform businesses about Nassau County resources and programming available. Resources covered included the Boost Nassau Small Business COVID-19 Recovery Loan Program, the Personal Protective Equipment Giveaway, the Restaurant Recovery Grant Program, and the Open Street Program for outdoor dining.
