COUNTY EXECUTIVE: Thank you. Thank you. Let's get down to business.

So it's been one year. First, I want to thank God Hashem, for giving me the strength to be County Executive. I pray that God gives me the wisdom, courage and compassion to serve the residents of this great county to the best of my ability.

Thank you, Presiding Officer Rich
Nicolello, Minority Leader Abrahams, and
all the members of the Legislature,
Comptroller Elaine Phillips, District
Attorney Anne Donnelly, our Clerk,
Maureen O'Connell, and all the other
elected officials who are here tonight.
Members of the union, members of my
staff, thank you for your hard work and
the great workers in Nassau County.

I especially want to thank our

county workers for the outstanding job
they did this past year coming out of the
COVID pandemic. I want to thank all of
our first responders, our volunteer
firefighters, our EMTs and our great
veterans and all of our employees,
whether they be corrections officers,
deputy sheriffs clerks, whether they work
in social services, thank you to each and
every one of you for all you do for the
citizens and residents of Nassau County.

Over the past year, my
administration has tackled issues head on
that have been swept under the rug for
far too long by previous administrations.
By making the tough decisions, we were
able to make the County more affordable
and safer.

As inflation reached 8% nationally, we were still able to submit a no tax increase budget. And as a result of our sound fiscal practices, we received a bond upgrade from the Wall Street rating agencies who have endorsed our record of

economic performance (applause).

I also worked with the Legislature to approve a comprehensive capital plan that will help to upgrade Nassau's critical infrastructure, protect our environment, resurface our roadways, give law enforcements the resources they need, and improve our parks and recreation areas, all without raising taxes (applause).

To keep costs low, especially for our seniors, veterans and young people, my administration is focused on expanding the tax base, driving local economic activity, and bringing some of the biggest and most prestigious companies in the world right here to Nassau County.

There is an interesting proposal to development the area around the coliseum known as the Hub. Las Vegas Sands has proposed an entertainment center, luxury hotel and casino for the Coliseum site. This resort would have local and celebrity residents, a luxury hotel and

Second, it must bring significant revenue to the County and surrounding areas, including construction and permanent jobs;

And third, it must have the support of the community.

We will continue to explore this possibility and will keep county residents informed throughout the process.

One of the first things I did upon taking office was asking that our great comptroller, Elaine Phillips, conduct a comprehensive review of the Department of Assessment. The Comptroller uncovered

Nassau County is bigger than ten states by population, and our GDP is larger than 145 nations in the United Nations. My administration is committed to doing big things. Attracting people to Nassau County is a major priority. We have world class healthcare, restaurants, shopping and beaches. Our housing stock is diverse and dynamic. We must market Nassau County as the vibrant and exciting

To enjoy great music and honor the heroic work of our first responders who stepped up to the plate during the COVID pandemic (applause). A record breaking crowd of over 25,000 people attended this event. The concerts also served to drive economic activity for our local residents, stores, hotels and other small businesses who struggled during the COVID pandemic. I am working on a star studded lineup for this summer, as well as hosting other major entertainment and sports events.

In partnership with Island Harvest and Long Island Cares Harry Chapin Food Bank. We had a Thanksgiving Eve food drive and collected more than 10,000 pounds of food (applause) with the help of our own Jericho native, singer

We also held parades to celebrate our state champion sports teams. Little League World Series participants and UFC champion.

For Presidents Week, we began a comprehensive marketing campaign to highlight our county parks and museums while children were off from school. Rather than spend thousands of dollars on a vacation because of inflation and high gas prices, we urged residents to stay right here in Nassau County and enjoy everything we had to offer.

Now, this is the good part. I am proud to say we almost doubled visitation during that weekend at our county parks, ice rinks and museums, providing low cost and fun ways for families to spend time together. We need to market Nassau County

This year, as Nassau County will be hosting the Korean American National Sports Festival, which will draw thousands of athletes from around the world to Mitchell Field. I will always be the greatest and biggest cheerleader for our communities and fight to protect our suburban way of life.

Unfortunately, in Albany, some folks have proposed legislation that threatens the suburban experience of Nassau County residents. Legislation is being proposed in this year's budget that demands a 3% growth in housing stock. For Long Island, the target would mean 38,000 new housing units in the next three years. This would add approximately 100,000 new residents to Nassau County in just three years. In order to meet this goal, suburban areas of Nassau County, like Lakeview, Massapequa and Port Washington, would have to add multi-story apartment buildings and multifamily homes. While

these goals may be attainable in other

parts of the state where they have

sufficient land, I do not believe this

one size fits all approach takes into

account the suburban character of Nassau

County, and the fact that we are

surrounded by water and already the most

densely populated suburban county in the

United States. The water aquifers would

be stretched to dangerous levels. Our

environment would suffer and traffic

would be unbearable. Our schools would be

overcrowded. It's a dangerous idea that

will destroy the quality of life that we

enjoy. This is why I will stand against

that state plan, but I stand willing to

negotiate with our leaders in Albany on a

common sense approach to housing that

takes into account the necessities that

we have here in Nassau County (applause).

There's another issue that has

arisen up in Albany, which I think would

be very deleterious to Nassau County. I

will stand against the plan in Albany to

move local elections to even years.

Moving local elections to even years will drown out local issues that our residents care about like roads, taxes, government services and benefits, where the media will only focus on national or major state issues. Local issues will be drowned out. We can't let that happen. We need to protect our local home rule and our local elections and our local elected officials and not get drowned out by a policy that would put us in a situation we haven't seen since the birth of this county.

I will also strongly oppose the State's proposal to raise the payroll tax from \$0.34 to \$0.50 for every \$100 of payroll. Nassau County residents should not have to bail out the bloated and ineffective bureaucracy known as the MTA. Residents cannot afford another tax, and certainly not to subsidize the MTA, which is using now train cars from the 1980s and delays continue in service. And as

Our Police Department, led by Commissioner Ryder, does a great job. Our cops are the most highly trained and dedicated in the nation. For example, after seeing countywide rise in thefts of catalytic converters, officers seized thousands of stolen catalytic converters and more than \$7 million from an organized crime ring, putting a significant dent in their operation. Thank you, Commissioner Ryder, and the dedicated police officers of Nassau County. I especially want to thank Senator Chuck Schumer for asking the Department of Justice to help us and send a special response team to Long Island to help crack down on these thefts (applause).

Together, with all of our unions, we resolved years of litigation and uncertainty regarding longevity (applause).

Our great men and women of the Nassau County Police Department solve the crimes and make the arrests. But Albany's woke progressive policies like cashless bail raised the age and other crazy laws are making us all less safe. We must repeal these laws which are designed to give criminals more rights than the victims. It must not continue (applause).

President Biden's border policies are also affecting us, more than just New York City. Just over a month ago, four
