A RESOLUTION SETTING FORTH THE OFFICERS AND EMPLOYEES DEEMED TO HOLD POLICY-MAKING POSITIONS FOR FILING YEAR 2022 (RELATING TO CALENDAR YEAR 2021) WHO SHALL BE REQUIRED TO FILE ANNUAL STATEMENTS OF FINANCIAL DISCLOSURE PURSUANT TO NASSAU COUNTY ADMINISTRATIVE CODE § 22-4.3 AND THE GENERAL MUNICIPAL LAW

WHEREAS, pursuant to Nassau County Administrative Code § 22-4.3(4)(b), the Nassau County Board of Ethics is required, annually, to determine the officers and employees of County Departments, Agencies, Boards, Commissions, or Entities who hold policy making positions and to make a list of such officers and employees; and

WHEREAS, pursuant to Nassau County Administrative Code § 22-4.3, the Board of Ethics is required to file, and has filed, such a list with the Clerk of the County Legislature; and

WHEREAS, said list does not include certain officers and employees holding titles who are statutorily required to file annual statements of financial disclosure regardless of whether they hold policy making positions pursuant to Nassau County Administrative Code § 22-4.3(4)(e); and

WHEREAS, pursuant to Nassau County Administrative Code § 22-4.3(4)(b), the County Legislature shall adopt a resolution either ratifying or modifying the list submitted by the Board of Ethics; and

WHEREAS, the County Legislature has, for filing year 2022 (relating to calendar year 2021) considered the Board of Ethics' memorandum to heads of all the County's Departments, Agencies, Boards, Commissions, or Entities regarding who should be considered a policymaker; and

WHEREAS, the heads of the County's Departments, Agencies, Boards, Commissions, or Entities have provided requested information and the identities of certain officers and employees needed to assist the Board of Ethics in promulgating a list of policymakers, by Department, Agency, Boards, Commission, or Entity; now, therefore, be it

RESOLVED, that the officers and employees set forth in the list as shown in Appendix A, attached hereto, are hereby deemed to be policymakers required to file an Annual Statement of Financial Disclosure, pursuant to the relevant provisions of Nassau County Administrative Code § 22-4.3; and be it further

RESOLVED, that it is hereby determined, pursuant to the provisions of the State Environmental Quality Review Act, 8 N.Y.E.C.L. section 0101 et seq. and its implementing regulations, Part 617 of 6 N.Y.C.R.R., and Section 1611 of the County Government Law of Nassau County, that this appointment is a "Type II" Action within the meaning of Section 617.5(c)(20) of 6 N.Y.C.R.R. ("routine or continuing agency administration and management, not including new programs or major reordering of priorities that may affect the environment"), and, accordingly, is of a class of actions which do not have a significant effect on the environment; and no further review is required.

PROPOSED LOCAL LAW -2022

A LOCAL LAW TO AMEND SECTION 21-29.10 OF THE NASSAU COUNTY ADMINISTRATIVE CODE WITH RESPECT TO CATALYTIC CONVERTERS

WHEREAS, catalytic converters are exhaust emissions control devices that reduce harmful pollutants in exhaust gas from internal combustion engines; and

WHEREAS, catalytic converters are an essential and legally required component of most gas- and diesel-powered vehicles; and

WHEREAS; these devices contain precious metals including platinum, palladium and rhodium, and are an attractive target for thieves that can easily sell these highly valued components to scrap metal dealers; and

WHEREAS, replacing stolen converters and repairing damages due to the theft can cost victims thousands of dollars; and

WHEREAS, as these catalytic converters are easily stolen by skilled thieves using common tools and are not marked, stamped or otherwise identifiable in a manner that would assist law enforcement to identify the vehicle from which the device was stolen from, the theft and sale of catalytic converters has skyrocketed as the price of precious metals have increased; and

WHEREAS, it is the intent of this Local Law to require scrap metal dealers in Nassau County to better document information on the seller of a catalytic converter to assist law enforcement in its mission to deter the theft of these devices and prosecute offenders; NOW THEREFORE

BE IT ENACTED by the County Legislature of the County of Nassau as follows:

Section 1. §21-29.10 of the Nassau County Administration Code shall be amended to include the following subsection:

- 5. Additional Requirements Regarding Purchase of Catalytic Converter.
 - a) In addition to the requirements of this section, a person attempting to sell a catalytic converter to a Purchaser shall provide to the Purchaser the following information:
 - the year, make, model, and vehicle identification number for the vehicle from which the catalytic converter was removed;
 - ii. a copy of the certificate of title or other documentation indicating that the seller has an ownership interest in the vehicle described in subdivision (i), or where the seller is the owner of a garage or repair shop and the catalytic converter was removed in connection with a motor vehicle repair, the name and address of the vehicle's owner and copies of all related invoices.
 - b) A Purchaser may not purchase a catalytic converter from a seller who does not comply with the requirements of subsection (a).
 - c) A Purchaser may not purchase a catalytic converter unless such Purchaser determines that the catalytic converter is consistent with the manufacturer's specifications for a catalytic converter from the vehicle for which the seller provided information under subdivision (a)(i).

- d) A Purchaser shall keep an accurate electronic record of each purchase of a catalytic converter made in the course of the Purchaser's business. The record must be in English and include the information required pursuant to §21-29.10 of the Nassau County Administration Code.
- e) A Purchaser shall preserve each record required pursuant to this section until the fifth anniversary date the record was made. The records must be available for inspection not later than seventy-two (72) hours after the date of purchase.
- f) On request, a Purchaser shall permit representatives of the Nassau County Department of Consumer Affairs or the Nassau County Police Department to inspect all records required to be kept pursuant to this title.

§ 2. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined to its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

§ 3. SEQRA Determination. It is hereby determined, pursuant to the provisions of the State Environmental Quality Review Act (SEQRA), 8 N.Y.E.C.L. Section 0101 et seq. and its

implementing regulations, Part 617 of 6 N.Y.C.R.R., and Section 1611 of the County Government Law of Nassau County, that the adoption of this local law is a "Type II" Action within the meaning of Section 617(c)(20) and (27) of 6 N.Y.C.R.R., and, accordingly is of a class of actions which do not have a significant effect on the environment, and no further review is required.

§ 4. Effective Date. This local law shall take effect immediately.

PROPOSED LOCAL LAW NO. - 2022

A LOCAL LAW TO AMEND THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY IN RELATION TO ESTABLISHING A NASSAU COUNTY MOVIE, TELEVISION, AND DIGITAL MEDIA COMMISSION.

BE IT ENACTED by the County Legislature of the County of Nassau as follows:

Section 1. A new Section 2109 is added to the County Government Law of Nassau County to read as follows:

§2109. Nassau County Movie, Television, and Digital Media Commission.

1. There is hereby established a Nassau County Movie, Television, and Digital Media Commission consisting of twelve (12) members, all of whom shall serve at the pleasure of the County Executive. Seven (7) members shall be appointed by the County Executive, three (3) members shall be appointed on the recommendation of the Presiding Officer of the County Legislature and two (2) members shall be appointed on the recommendation of the Minority Leader of the County Legislature. The County Executive shall designate one member as Chairperson. Members must have a background in movie /television/digital media business, development, labor, or other related industries.

2. The Nassau County Movie, Television, and Digital Media Commission shall receive no monies from the County of Nassau unless an appropriation specifically for the use of the Commission is approved by the County Legislature.

3. The Nassau County Movie, Television, and Digital Media Commission is authorized to obtain monies through private fundraising, which shall be governed by

bylaws duly adopted by the Nassau County Movie, Television, and Digital Media Commission and filed with the Nassau County Board of Ethics.

- 4. The Nassau County Movie, Television, and Digital Media Commission shall:
 - Concern itself with any and all matters pertaining to the development and use of Nassau County by the movie, television and digital media industries.
 - b. Cooperate and assist the movie, television and digital media industries when within the County on matters beneficial to the general welfare and economic development of Nassau County.
 - c. Encourage, promote and assist the movie, television and digital media industries in utilizing the natural and man-made resources within Nassau County.
 - Advise, assist and cooperate with other agencies of the County, local governments, boards and agencies, commissions and private enterprise pertaining to the aforementioned industries.
 - e. Solicit the use of Nassau County as location sites for prospective content producers.
 - f. Solicit available locations and accompany prospective content producers in visiting sites. Assist prospective producers in selecting such sites.
 - g. Coordinate movie, television, and digital media projects in the County with regard to laws, permits, fees, or any other government related obligations.

- Invite, from time to time, any other governmental officials to participate in its deliberations or otherwise assist it in discharging its duties under this section.
- The Board shall meet at least once a year, may schedule additional meetings as necessary, and shall post a notice of all such meetings on the Official Website of Nassau County.

§ 2. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 0101 et seq. and its implementing regulations, Part 617 of Title 6 of 6 N.Y.C.R.R. and Section 1611 of the County Government Law of Nassau County, that the adoption of this local law is a "Type II" Action within the meaning of Section 617.5(c)(26) of 6 N.Y.C.R.R., and, accordingly, is of a class of actions which do not have a significant effect on the environment; and no further review is required.

§ 4. This local law shall be effective immediately.

Ι want to share an amazing story with everybody 16 17 tonight. 18 On March 9, 2022 Fourth Precinct 19 officers were dispatched a call in Oceanside 20 for a 14-year old boy not breathing and in 21 cardiac arrest. Police officers Apath, 22 Mantovani were first on the scene and observed 23 the aided on his bed. He did not have a pulse 24 and was not breathing. They placed him on the 25 floor and started CPR. Officers Apath,

Full - 5-23-22 1 Mantovani and Drechsel also attached the AED 2 3 while continuing CPR. 4 Police medics Sutton and Santiago 5 arrived on the scene and attached their б equipment to the child. After a shock they 7 got a pulse back. The child did then start to 8 The breathing was shallow. breathe. The 9 child was intubated and medics gave him 10 medicine and fluids. The officers then 11 transported him to South Nassau Hospital for 12 further treatment. 13 The child was transferred to LIJ 14 Cohen's Children Hospital. He was intubated 15 for several days and eventually was 16 discharged. He amazingly made a full

17 recovery. The child was diagnosed with a

18 heart defect and had a defibrillator

19 implanted.

If not for their quick response and calm under pressure the situation could have had a very different outcome. It is my honor to announce police officers Apath, Mantovani, Drechsel and police medics Sutton and Santiago as legislative top cops for May 2022.

I was in the 10 hospital for two weeks and the only people I 11 could really thank is God and my family for 12 always being there for me every day in the 13 hospital. And luckily now I'm alive and just 14 really big outcome from all this. Very 15 happy. I'm glad. I'm blessed. 16 MR. RODRIGUEZ: Hi everybody 17 I was surprised tonight. I was raised here. 18 here all my life. I can't believe it. I'm 19 really surprised the police, the medics and 20 ambulance. I remember 3:25 a.m. in the 21 morning my daughter case closed so quick. Not even one minute, two minutes, almost 20 22 23 police. I'm blessed. I can't believe it. 24 They saved my son's life. I'm really happy 25 all the service of Nassau County police. Ιt

1 Full - 5-23-22 2 is the best medical police service and I 3 really surprise at police. They do all of 4 Nassau County. I'm really so happy. 5 Certainly they do amazing for the service they б do. Amazing to save my son's life. Thank you 7 so much. 8 COMMISSIONER RYDER: We always we

9 sit here and say thank you for the tools and 10 the training that you give all of us. All of 11 our members. You see what it comes to and 12 what it does. HBO should -- this is what a 13 movie is made of. This is what they should 14 film. Real heroes doing real things. And I'm 15 really jealous of this kid's hair.

16 We're very happy and thankful for 17 everything that you've given us. Thank you. 18 MR. DRECHSEL: I'll keep this 19 very brief. I just want to first thank the 20 Nassau County legislature, Commissioner Ryder, 21 PBA top cop committee, PBA president Shevlin 22 and executive board members. And on behalf of 23 myself, officer Mantovani, officer Apath, 24 police medic Sutton and police medic Santiago 25 we thank you for this honor.

3 All right. But all of you once 4 again, thank you very much and let us all just 5 remember how important our first responders б are to us and let us always celebrate the work 7 that they do and the people who they are. 8 Thank you.

9 LEGISLATOR KOPEL: The Fourth 10 Precinct and my district largely coincides and as someone who lives in the Fourth Precinct 11 12 and is protected by the Fourth, by the fine 13 officers of the Fourth Precinct, I'm very 14 gratified to see how diligent you are and it's 15 not a surprise to me because I see it every 16 day. I see it all the time. We live in a low 17 crime area. You guys just provide exemplary 18 protection and service. I'm just very 19 grateful for everything that you do. 20 Jonathan second chance at life. 21 You're destined for great things, right? I 22 want to see great things from you. 23 LEGISLATOR NICOLELLO: I just 24 wanted to add, month after month we see when 25

we do these recognitions the incredible work

that our law enforcement does. But this time you're also seeing it from the perspective of the family. 9 LEGISLATOR WALKER: I would just 10 like to add too that as you were speaking, as 11 our officers were speaking and portraying that 12 night, Jonathan, seeing your dad behind you 13 and the tears flowing down. You kept this young 18 angel here with us because of all the work you 19 do. God bless you all. Jonathan, to see you 20 here tonight just touches my heart. God bless 21 and good luck.

subject's vehicle which had numerous VTL
violations and he notified the other
supervisors who were close by. Sergeant
Schuerlein then pulled the vehicle over to a
safe location.

11 The other supervisors immediately 12 showed up. During this time the subject 13 started becoming irate, was continuously 14 moving around and was verbally combative to 15 the supervisors. The subject was then placed 16 in handcuffs and placed in the back of the 17 police car. The subject's vehicle was 18 impounded and during this impound the vehicle 19 was searched for an inventory search. Which 20 at that time a loaded firearm was recovered 21 from the vehicle. This gun was determined to 22 have been stolen from Alabama. These 23 supervisors did an excellent job in 24 coordinating their efforts.

25 While knowing they might be

You 8 never know who you're pulling over. If the 9 person in that car is wanted. If the person 10 is armed. Our officers put themselves in 11 harm's every day. We have officers every day 12 getting injured in this job. 13 Crime is on the rise in Nassau 14 County and New York City is falling apart. We 15 are not immune to what is going on. 16 So, Presiding Officer Nicolello and 17 all of the rest of the legislators that 18 support us I want to thank you again. And I 19 want to congratulate sergeant Ben Schuerlein, 20 Ryan Surillo and detective sergeant Thomas 21 Kananowicz for taking another gun off the 22 streets of Nassau County. Thank you. 23 COMMISSIONER RYDER: Aqain, thank 24 you. We ask our supervisors every day to lead 25 our very young department. Sixty percent of

A combative suspect arrested. 14 That's a shooting that never took place. So, 15 to serve and to protect you live that every 16 day. We thank God for you. Keep up the great 17 work. 18 LEGISLATOR NICOLELLO: Would you 19 like to join us for a presentation. I did 20 notice one thing though. You know you're 21 getting old when the police officers look like 22 high school students. Now you have 23 supervisors looking like college students. 24 Great job guys. Wonderful. 25 We also are privileged to have a

 Association, Inc. Mike is it you? Mike
 Maloney is going to do the presentation? Tim

б MR. MALONE: Good evening. On 7 June 20, 1969 a young man from Valley Stream, 8 barely 21 years old, raised his right hand and 9 was sworn in to the Nassau County Police 10 Department. This man now became patrolman 11 Gary T. Ferrucci, shield number 2230. Upon 12 completion of his training Patrol Ferrucci he 13 was assigned to the Fourth Precinct in 14 Hewlett.

15 In 1971 Gary was assigned to the 16 Nassau County Highway Patrol Bureau and would 17 spend the next ten years patrolling the Long 18 Island Expressway. This is where patrolman 19 Ferrucci began making a name for himself. 20 During his tenure in highway, Gary 21 wrote tens of thousands of traffic tickets and 22 made over 1100 DWI arrests. Speeding 23 motorists and drunk drivers feared patrolman 24 Ferrucci. They either slowed down, stopped 25 drinking or completely avoided the LIE. This

1

2 was if they were lucky enough to not have 3 their car impounded by Gary.

Now, I'm not sure if this is true
but there's a rumor that the revenue created
from the tickets Gary issued had kept the
Nassau County budget balanced during the
1970s.

9 On December 16, 1979 Gary's life 10 had changed when his close friend and partner 11 police officer Daniel Greer was killed in the 12 line of duty after being struck by a drunk 13 driver. Gary's loyalty to his partner still 14 remains and to this day he has kept in contact 15 with officer Greer's family. Present here this evening is Colleen Greer. Colleen has 16 17 never met her grandfather but thanks to Gary 18 Ferrucci she is able to hear stories about his 19 life and his job as a Nassau County police 20 officer. Because of Gary, Colleen can and 21 will continue to keep police officer Daniel 22 Greer's legacy alive.

In January of 1981 Gary was assigned to the detective division and worked in the third squad for the next ten years.

1 Full - 5-23-22 2 From here on out he was no longer patrolman Ferrucci, shield number 2230, but detective 3 4 Ferrucci shield number 165. In case you're 5 wondering, this was not necessarily good news б either for people driving in Nassau County. 7 Because when Gary wasn't investigating cases, 8 he was out looking for speedy motorists and 9 drunk drivers continuing to write thousands of 10 tickets.

In 1991, after a decade of working in the third squad, Gary was assigned to the homicide squad. Specifically the vehicular crimes and reconstruction section, now known VCAR. It was here where Gary would combine his experience from the third squad and his love for highway patrol.

18 The VCAR section investigates 19 serious auto accidents and vehicle-related 20 deaths. While some of these death 21 investigations are tragic accidents, many are 22 criminal cases that involve driving under the 23 influence of drugs and alcohol amongst other 24 crimes.

Many times these investigations

1 Full - 5-23-22 2 become high profile and newsworthy cases 3 Whether an investigation is criminal in also. 4 nature or not there is not one case that is 5 more important than another. Each victim's б family demands answers and deserves closure. 7 This cannot happen without a thorough 8 investigation. It takes a dedicated 9 individual to work in this office and for Gary 10 it was the perfect spot. 11 From 1991 to present detective 12 Ferrucci has been the lead investigator in more than 700 vehicle-related deaths. 13 14 Including two of our own Nassau County police 15 officers who were killed in the line of duty. 16 One of the duties of an 17 investigator in the homicide squad is to make 18 death notifications. Notifying someone about 19 the death of their loved one can be a very 20 difficult task. It makes a person's worst 21 nightmare become a living reality. 22 It was Gary who had the 23 responsibility to notify a family member that 24 one of their loved ones was killed while 25 coming home from school or work. If a child

1 Full - 5-23-22 2 went for a bike ride and was killed by a drunk 3 driver it was Gary who carried the burden of 4 telling a parent that their son or daughter 5 will never be coming home. Whether this was б in the middle of the night or on Christmas 7 morning Gary had done this over 700 times. 8 Each time with dignity and compassion. Gary 9 is an expert at what he does and takes great 10 pride in his work. 11 When Gary signs off duty and leaves 12 the office he's not actually going home. From 13 locating and interviewing a witness, to 14 viewing surveillance video, he's following up 15 on his cases. Gary does this almost every day 16 and has never asked for any overtime or 17 compensation. He does this because he cares 18 about his victims and he cares about their 19 families. 20 Throughout detective Ferrucci's

career he's been awarded countless meritorious duty and life saving awards. He's also received three medals of commendation and a purple heart which was awarded to him in 2003.

1 Full - 5-23-22 2 In 2021 Gary was recognized for his 3 service and designated a first grade 4 detective. This prestigious designation is 5 solely based on merit. Nobody in the entire б department deserved this more than him. 7 Gary Ferrucci's public service does 8 stop with law enforcement. Since 1965 he's 9 been an active member of the Valley Stream 10 Fire Department. Gary's also been an EMT 11 since 1972. And for the past 35 years he's 12 been a certified New York State EMS instructor 13 training thousands of EMTs for free on his own 14 time. 15 Gary's public service and 16 unwavering commitment to both the police 17 department and the residents of Nassau County 18 will always be appreciated. 19 On June 9th detective Ferrucci will 20 be turning in his shield and retiring from the 21 police department. Over the course of his 22 53-year career Gary Ferrucci has worn many 23 hats, including being a police officer, 24 detective, fire fighter, EMT, educator, 25 husband, father, grandfather and a friend. We

1 Full - 5-23-22 thank detective Ferrucci for his service and 2 wish him the best on his retirement. 3 4 This is archived in our photo 5 section. This is a picture of Gary that was б taken June of 1969. 7 MS. GREER: So, my name is 8 Colleen Greer. I am Daniel Greer's 9 granddaughter. Gary was my grandfather's 10 partner. He was with him the day that he 11 died. I didn't know this. My family didn't 12 know this for a long time. This year in 13 December I was looking at my grandfather's 14 memorial page online, and I found a comment by 15 Gary and first something said call and I just 16 Googled Nassau County Police Department. Ι 17 said hi. Does anybody know who this is? And within an hour he called me back and he told 18 19 me all these stories about my grandfather. It 20 was just so amazing. A couple of days after 21 Christmas he came all the way to my house in 22 Miller Place. I remember saying to him "Are 23 you sure you want to come?" He said "Well, 24 the car's got four wheels. It's fine." He 25 came and he met with my kids and my husband

FERRUCCI: Ladies and 16 gentlemen thank you. It's a very tough thing 17 for me to do. However, there are some names I 18 would like to name that I remember every day. 19 Being up on the Long Island Expressway and 20 being a detective in the Nassau County Police 21 Department there are names that stick in your 22 head forever. 23 Matt Giglio. Matt was in the 24 rescue company with me. I brought him in.

Matthew was shot on Hempstead Turnpike after

I had the 5 chance to go to the family, talked to them and б be there every time there was some sort of a 7 court presentation for the defendant to be 8 released. Never happened. He's already at 9 this time deceased because he hung himself in 10 jail.

Danny Greer. What more can I say about Danny Greer? The diesel chaser. We used to all have a name on the expressway about what we do and Danny was just incredible. Funniest laugh that you would ever hear.

17 That day things didn't go well. We 18 had just had breakfast at the Holiday Inn and 19 he went east and I went west. A few minutes 20 later there were people who were yelling we 21 need help. We need help. Came back and I 22 found him in a ditch along side the Long 23 Island Expressway.

Danny, even in death, was able to
help solve his case because it was the first

His ear 5 impressed into the vehicle and Danny was able б to tell us what kind of car. About three days 7 later the defendant was found and charged. 8 Mike Califano, highway patrol 9 Mike was stopped at exit 33 and was bureau. 10 telling a young lady to get back into truck of 11 your car, excuse me, because it's too 12 dangerous here. 13 At that time a truck carrying three 14 other vehicles drove up on top of Mike's car 15 and trapped him in the vehicle. I got to the 16 scene and I was told that Mike is deceased. 17 He's not. I'm a medic for many, many years. 18 I teach it in the Nassau County EMS academy. 19 We transported him to NUMC He was not dead. 20 and at that time he was pronounced dead. 21 The reason is because people, the 22 family need to have some opportunity to say 23 this was just not just an auto accident. 24 Artie Lopez. Another gentleman

25 that I met one night while he was towing a car

A few days 3 4 later we were on the Cross Island Parkway 5 where he was shot by a person who just didn't б know him. He was walking up to a scene 11 and was struck and shot by another officer. 12 It was simply something that happened. But I 13 was at the scene and we gave him every 14 opportunity to live. That's what my job was. 15 What it still is. 16 It's hard for me to say good-bye. 17 I'm not saying good-bye. What I'm saying is 18 thank you to everyone who I've had the 19 opportunity to work with, talk with and give 20 them some civility. Thank you tonight. Thank 21 you all. Please be safe and I appreciate the 22 opportunity to be a Nassau County detective 23 thank you. 24 LEGISLATOR NICOLELLO: Legislator 25 Gaylor.

Eight excellent police duty 9 awards, 12 meritorious police awards, one life saving award, three medals of commendation. 10 11 one purple heart and multiple top cop awards. 12 Truly impressive. 13 On top of that, somehow you found 14 time to serve as a volunteer with the Valley

Stream Fire Department for 57 years now.
Impressive. An EMT technician since 1972. A
trainer in the EMT field training our young
men and women how to be EMTs. These lines of
work have earned you countless other awards as
well.

I'm touched to learn about your commitment to the family of your former partner and close friend Daniel Greer, who lost his life in the line of duty. And Ms. Greer standing next to you is truly

2 blessed to have come to know you recently.
3 Come to be a friend. Come to accept you as

19	elected as classroom vice president of the NCC
20	Federation of Teachers.
21	I want to thank Legislators
22	Nicolello, Ford, Rhoads and Giuffre for taking
23	time out of their busy schedules to tour our
24	campus and learn firsthand about our dedicated
25	faculty's proposed initiative to keep the

1 Full - 5-23-22 2 college viable. Including the need for additional operating funds to hire new 3 4 replacement faculty and capital improvements. 5 Including a new performing arts building to be б the cultural hub within the Mitchell Field 7 hub. 8 I also want to extend another open 9 invitation to any legislator that would like a 10 tour. We would welcome such an opportunity. 11 Since it's opening in 1959 in the 12 west wing of the building that you usually 13 meet in, when it was called the old county 14 courthouse, NCC has often been described as 15 the jewel of Nassau County in New York State's 16 community college system. We have been one of 17 the prime economic engines for the county and 18 a magnet for attracting residents. 19 It is time to reinvest in the 20 college so that faculty can offer continued 21 quality academics, programs and curriculum to 22 prepare students of the 21st century. 23 The college will now go into it's 24 15th year without a funding increase for its 25 operating budget from Nassau County. This,

Full - 5-23-22 along with a decade-long cut in state funding, has led to the shrinking of full-time faculty, increases in tuition and cuts in student services. Along with the college's failure to develop and offer new programs and initiatives.

8 Yet, our own board of trustees 9 won't ask for an increase in our operating 10 budget. Where other community college board 11 of trustees regularly ask for and receive one 12 to two percent increases for their operating 13 budget ours has not. This isn't sustainable. 14 The college board of trustees will not ask for 15 an increase unless they believe that you will 16 approve it. It's a Catch-22 situation that 17 results in stagnation of the college 18 enrollment and missed opportunities to serve 19 our community.

Accordingly, we ask the legislature Accordingly, we ask the legislature to send back the current proposed college budget and ask the board of trustees and the administration to work with the faculty and revise the budget to reflect an increase in the county's contribution and to use that

They form part of the 10 needed workforce. Become our accountants, our 11 lawyers, our small business owners. Even 12 legislators. I know many of you are alumni. 13 Yes, they stay on to become our valued 14 neighbors and taxpayers. 15 In sum, Nassau Community College 16 students are our future. In asking the county 17 to return the proposed zero budget and offer 18 to raise the college's operating budget we are 19 in reality asking the county to invest in its 20 residents, its businesses and its future. The 21 benefits are limitless. We trust that you 22 share our belief that a great county deserves 23 Thank you. a great community college. 24 LEGISLATOR NICOLELLO: Thank you 25 Mr. Stern. Meta J. 9 Just looking at recent legislation 10 as late as Wednesday that the senate reached a 11 deal to pass sweeping military toxic exposure 12 legislation later this summer that paved the 13 way for millions of veterans exposed to burn 14 pit smoke and other battlefield toxins.

Being a 9-11 first responder and having been exposed to many of those similar toxins, as a civilian I'm trying to basically encourage those who are helping to rebuild our city. Good, bad or indifferent it is still our city.

We need to focus on what we can do here in Nassau County through NUMC to better serve our veterans and their families. There is great opportunity there. The location is apropos. There are many things that

particularly this legislature can do almost immediately to upgrade our very hard working, very committed veteran services organization. We can step it up to an agency which would increase its opportunities and access to state and federal funding.

8 We can also look at developing 9 projects. Maybe setting up a research 10 facility within NUMC that would bring in some 11 of this funding for the toxic fumes that will 12 bring support to our Vietnam veterans. Ιt 13 would help us because we have a large 14 constituent of war widows that live in Nassau 15 County and Long Island. We can have a family 16 support and resource center. Similar to what 17 they do upstate.

18 It seems that we have a lot of 19 resources in New York State that support our 20 veterans in locations that have much smaller 21 veteran populations.

So, I'm hoping that I don't have to reach out to my friend Gary to borrow that tank. But as many of you know, where there's a will for me I can probably make a way.

They're stealing them, selling them 23 for two to \$300 to the scrap yards. 24 By getting the scrap yards to 25 register these items and who brought them to

3	eventually close out these cases.
4	They don't do one in the
5	nighttime. They do 15, 20. And these poor
6	people get up in the morning, they go to start

10	appreciate it going forward.
11	LEGISLATOR NICOLELLO: Thank you
12	commissioner. From the statistics that I've
13	been given between 2019 and 2020 nationwide
14	the increase in catalytic converter thefts was
15	over 325 percent. We've also seen a
16	substantial increase in these thefts in Nassau
17	County. The cost to replace these, not the
18	cost these thieves are getting from the scrap
19	metal dealers or elsewhere, black markets, but
20	the cost to replace them can be several
21	thousand dollars. Because, as you said, they
22	damage the exhaust system. You have to find
23	the catalytic converters on the market. And
24	with the supply chain issues it's sometimes
25	difficult to do this. This is a major issue

2 affecting our residents.

3 COMMISSIONER RYDER: Absolutely. 4 The two crimes that plaque us the most right 5 now are stolen cars and catalytic converters. б Thankfully our violence is not up. Our 7 violence is down. We've done a great job. 8 You just saw the heroes that were before us. 9 But by doing this it gives us a tool in the 10 tool box that we can actually go out and find 11 somebody. If they keep scrapping the stuff 12 and there's nobody behind it, we don't know 13 who it is, we can't find them. 14 LEGISLATOR NICOLELLO: Anyone 15 else? Any legislators? 16 COMMISSIONER RYDER: Thank you. 17 LEGISLATOR NICOLELLO: Thank you 18 commissioner. Any public comment on this 19 item? 20 As I said in MS. MEREDAY: 21 committee weeks ago, I definitely support 22 I'm just again, I just want clarity this. 23 with regard to this overall registration 24 process. Who's monitoring that? We all 25 understand what the end game is. But at the

LEMOINE: Good evening. 8 Chris Lemoine from the administration. 9 Clerk item 148-2022 is a local law 10 that amends the Nassau County charter by 11 establishing a Nassau County movie, television 12 and digital media commission. The commission 13 is being established to take advantage of the 14 economic opportunities offered by the county's 15 unique location and resources in connection 16 with the movie television, streaming and other 17 digital media productions. The commission will consist of 12 18 19 members each appointed by the county 20 executive. Seven will be directly appointed 21 by the county executive. Three will be 22 appointed by the county executive upon 23 recommendation of the presiding officer. Two 24 upon recommendation of the minority leader. 25 And the county executive will designate one

I was one of the sponsors of this б legislation when we created it the first time 7 back 300 years ago. 8 LEGISLATOR FORD: Since we 9 already had a commission, thank you presiding 10 officer, a long time ago what would basically 11 be the responsibilities of the commission? 12 MR. 19MR. LEMOINE:As of right now I20believe there's only one, yes.

LEGISLATOR FORD: I'll be follow up because I'd like to know who that person is and what their responsibility would be. Then the commission, I know that they used to bring in people who worked in the movie industry

LEMOINE: Yes. б LEGISLATOR NICOLELLO: I think 7 primarily this group will be promoting the 8 film industry. I think to the extent that 9 you'll have people from the industry who are 10 involved with this I think it probably would 11 be more effective than a single county 12 employee or two. It should in theory help to 13 encourage. We're doing well with television, 14 filming, with movies, etcetera but I think it 15 would do much to encourage that. 16 LEGISLATOR FORD: I would agree 17 it would enhance. But it's also good to have 18 someone work in the area. That's what I 19 meant. 20 LEGISLATOR NICOLELLO: Any other 21 legislators want to weigh in? I think we're 22 good Chris. Any public comment? 23 MS. MEREDAY: I get that we --24 again, I support this legislation. I think 25 it's important. I think it's timely. But
