2 second. Seconded by Legislator Ferretti. Are
3 there any other nominations? Hearing none, I
4 will entertain a motion to close the floor for
5 nominations for a clerk pro temp.

6 Moved by Legislator Rhoads.

7 Seconded by Legislator Ford who was about to
8 say that. All in favor of closing nominations
9 signify by saying aye. Opposed? The ayes
10 have it by a vote of 19 to nothing.

11 The nomination of Michael Pulitzer
12 as clerk pro temp is now before the members of
13 the legislature. We need a voice vote to
14 confirm Mike Pulitzer as clerk pro temp. All
15 in favor signify by saying aye. Those
16 opposed? That passes unanimously.

17 Let the record indicate that I am
18 reporting that with a vote of all members of
19 the legislature present in voting Michael
20 Pulitzer as the clerk pro temp by a vote of 19
21 to nothing. Congratulations Mr. Pulitzer.

22 MR. PULITZER: Thank you
23 Legislator Nicoletto. The next order of
24 business is procedural Resolution 2-2022,
25 which is the election of the presiding officer

9 The next item of business is
10 procedural Resolution 3 of 2022. A resolution
11 as to procedure to appoint Michael Pulitzer as
12 clerk of the legislature pursuant to the

14 May I have a motion. Moved by
15 Legislator Walker. Seconded by Legislator
16 Schaefer. Is there any debate or discussion?
17 Any public comment? Hearing none, all in
18 favor signify by saying aye. Those opposed?
19 Carries unanimously. Congratulations.

20 MR. PULITZER: Thank you
21 Presiding Officer. I would like to thank you,
22 the presiding officer, the entire legislature
23 for expressing their faith in me. It's a
24 privilege to serve all of you, and I thank you
25 for the opportunity. I would also like to

23 of the legislature for the calendar year
24 2022. Is there a motion? Legislator Pilip

5 Now we have to create several
6 committees that are not already established by

9 Economic and Community Development, Labor and
10 Transportation. Legislator McKeivitt makes
11 that motion. Seconded by Legislator Drucker.
12 Any debate or discussion? Any public
13 comment? All in favor signify by saying aye.
14 Opposed? Passes unanimously.

15 Resolution 7 of 2022 is a
16 resolution to establish the committee on
17 Towns, Villages and Cities. Legislator Mazi
18 Pilip makes that motion. Legislator Lafazan
19 seconds it. Any debate or discussion? Any
20 public comments? All in favor signify by
21 saying aye. Opposed? Passes unanimously.

22 Resolution 8 as to procedure is a
23 resolution to establish a committee on
24 veterans. Legislator Kennedy makes that
25 motion. Legislator Mule seconds the motion.

3 signify by saying aye. Those opposed?
4 Carries unanimously.

5 Resolution 9 of 2022 as to
6 procedure is a resolution to establish a
7 committee on senior affairs. That's moved by

9 Mule. Any debate or discussion? Any public
10 comment? All in favor signify by saying aye.
11 Those opposed? Carries unanimously.

12 Resolution 10 of 2022 as to
13 procedure is a resolution to establish a
14 committee on aircraft noise. Moved by
15 Legislator Gaylor and seconded by Legislator
16 Solages. Any debate or discussion. Any
17 public comment? All in favor signify by
18 saying aye. Those opposed? Carries
19 unanimously.

20 Resolution 11 of 2022 is a
21 resolution as to procedure to establish a
22 committee on assessment. Moved by Legislator
23 Rhoads. Seconded by Legislator
24 DeRiggi-Whitton. Any debate or discussion?
25 Any public comment? All in favor signify by

1 Full - 1-10-22

2 saying aye. Those opposed? That carries
3 unanimously.

4 Pursuant to Section 2211 of the
5 Nassau County charter the members of the
6 legislature representing two political parties
7 who received the highest and next highest
8 number votes in the county at the general
9 election in which the governor was chosen
10 shall designate in writing an official
11 newspaper and file this designation with the
12 office of the clerk of the legislature.

13 Both designations have been
14 submitted. The Majority has chosen Newsday,
15 as does the Minority. So Newsday is selected
16 as the official newspaper of the county
17 legislature.

18 At this time the floor is open for
19 purpose of announcing committee assignments
20 and appointments of chairs and vice chairs of
21 all committees of the legislature.

22 Legislature has the following committees.

23 Rules, Finance, Public Works, Public Safety

24 Health and Social Services, Government

25 Services and Operations, Planning, Development

2 and the Environment, Minority Affairs, Towns
3 Villages and Cities, Economic and Community
4 Development and Labor and Transportation,
5 Veterans, Senior Affairs, Aircraft Noise
6 Abatement, Assessment.

7 Additionally, Section 182 of the
8 charter requires the county to create a Budget
9 Review Committee for the purpose of
10 maintaining general supervision of and liaison
11 with the Office of Legislature Budget Review.
12 The members of this committee shall also be
13 designated.

14 Minority Leader Abrahams, I will
15 begin with my designations and then I ask that
16 you make yours as the committees are called.
17 Okay. Rules. I'm just going to give the last
18 names to shorten this. Nicolello chair, Kopel
19 vice-chair, Rhoads and Schaeffer.

20 LEGISLATOR ABRAHAMS: Presiding
21 Officer, I don't have the list in front of
22 me. I can do Rules, which is Legislator
23 Bynoe, DeRiggi-Whitton and myself. But I
24 would ask one of my colleagues that actually
25 has the list in front of them to do it for me.
