

To Whom It May Concern:

The County is in receipt of your letter dated June 3, 2015, requesting the withdrawal of your bid for the above indicated contract in the amount of \$4,481,000.00. Your withdrawal request is based on the fact that forty-five (45) days has passed without an award on the contract. You state that the impact of a late indeterminate award date makes it impossible to determine when the work could be scheduled and performed. Given the dates which have thus far been discussed, you have expressed concern that your company would face substantial increases in the cost of labor, equipment, and material availability, none of which was contemplated in your bid.

Based upon your concerns, the Department will grant the withdrawal of your original bid.
