Contract Summary

Purpose: The services to be provided by Counsel under this Agreement shall consist of continued representation of Nassau County in the following cases: Shakeria Little, Individually and as Administrator of the Estate of Antwan Brown v. County of Nassau, et. al., Docket # 14-CV-125 (JFB) (GRB); Mevyo Jean v. County of Nassau, "Chief Frank Doe", Karen G. Dowling, et. al., Docket # 14-CV-1322; Bobby Hayes v. County of Nassau, Nassau County Police Department, et. al., Docket # 15-CV-0398 (the "Services").

Method of Procurement: A Request for Qualifications (RFQ) was issued and a panel of firms qualified to provide legal services for the County has been established. The firm Goldberg Segalla, LLP ("Goldberg Segalla") has been added to this panel. After a review of the panel, the firm Goldberg Segalla has been selected to handle the matters as described above because of their experience, expertise in the subject matter, and availability. This is a new contract that will ensure the continuity of representation through the completion of services of the above referenced cases. Services provided by Counsel have been satisfactory to date.

Procurement History: The firm, Goldberg Segalla, submitted a proposal in response to the RFQ and was been added to this panel. After a review of the panel, based on the firm's experience, expertise in the subject matters, and availability, the firm has been determined to be qualified by the Department.

Description of General Provisions: As described above. The County Attorneys Office is transitioning to case-specific contracts where matters assigned to a firm are identified with a contract term, for specific matters (such as case names) and the maximum amount is for the life of the assigned matters.

Impact on Funding / Price Analysis: \$200,000 maximum amount, \$25,000 initial encumbrance.

Change in Contract from Prior Procurement: maximum on CQAT17000012 was \$148,000.
