3     main break in Valley Stream this morning. I

5     It's all yours.

6                   MR. ARNOLD:     This item, as you  
7     state, is an IMA with the district up in Great  
8     Neck for them to provide engineering services  
9     to look to expand their service area. The  
10    county is providing funding of \$145,000 in  
11    that endeavor.

12                  LEGISLATOR GAYLOR:     Is there any  
13    debate or discussion? Any fellow legislators  
14    want to say anything? Comment? Any public  
15    comment? I'm not hearing anything so I'm  
16    going to take a vote. All in favor please  
17    signify by saying aye. Are there any  
18    opposed? No. The item passes unanimously.
