Narrative

<u>Purpose</u>: To authorize and award a purchase order for Hexagon/Intergraph CAD (Computer Aided-Dispatch), a reporting tool currently used to pull data from the Intergraph CAD system to create reports for the Nassau County Police Department.

Discussion: This is a sole source purchase. Intergraph Corporation d/b/a Hexagon Safety & Infrastructure is the creator and owner of the Hexagon Software copyrighted under Copyright Act of 1976,17 U.S.C. Because the software is propriety and copyrighted in accordance with the end user license agreement for Hexagon Software, Intergraph is the only vendor legally authorized to provide maintenance and support for the software and from which the County can purchase additional software licenses. This purchase is for maintenance and support for the Police Department's Intergraph CAD system for the period of August 1, 2021 through July 31, 2022. The County is purchasing this maintenance and support pursuant to Exhibits C and D to the Master Services Agreement (MSA) between Intergraph Corporation and Nassau County dated October 1, 2015, which survives the expiration of the MSA, and incorporates by reference the terms of the MSA.

Impact on Funding: The maximum amount authorized under this purchase order shall be Eight Hundred Seventy-Six Thousand Five Hundred Twelve Dollars and Seventy-Six Cents (\$876,512.76) from general funds PDPDH1568

Recommendation: Department of Shared Services, Office of Purchasing recommends an award be given to Intergraph Corporation d/b/a Hexagon Safety and Infrastructure Inc. as the sole source for this purchase order.
