- 6 MR. PULITZER: Thank you madam.
- 7 Legislator Carrie Solages.
- 8 LEGISLATOR SOLAGES: Here.
- 9 MR. PULITZER: Legislator Siela
- 10 Bynoe.
- 11 LEGISLATOR BYNOE: Here.
- 12 MR. PULITZER: Ranking Member
- 13 Arnold Drucker.
- 14 LEGISLATOR DRUCKER: Here.
- MR. PULITZER: Legislator Denise

- MR. PULITZER: We have a quorum
- 4 ma'am.
- 5 LEGISLATOR SCHAEFER: Thank you.
- 6 We're going to start with clerk item 268-21,
- 7 which is a resolution authorizing the county
- 8 of Nassau to endorse the application of the
- 9 Trust for Public Land for a grant for the
- 10 Empire State Trail extension project.
- 11 Can I have a motion? Moved by
- 12 Legislator Rhoads. Seconded by Legislator
- 13 Solages. The item is before us.
- MR. SALLIE: Sean Sallie, Nassau
- 15 County Department of Public Works. This item
- is essentially a request from the Trust of
- 17 Public Land request for a municipal resolution
- of support in conjunction with its application
- 19 to the New York State Parks Department under
- the consolidated funding application process.
- 21 The Trust for Public Land is
- 22 seeking funding to advance the design of its
- 23 Long Island Empire Trail extension which would
- 24 create a multi-use trail between the
- Oueens-Nassau border out to the Twin Forks.

- 2 They're working with both Nassau County and
- 3 Suffolk County as far as the planning and
- 4 preliminary design is concerned.
- 5 Again, the Trust for Public Land, a
- 6 not-for-profit, is seeking grant funds through
- 7 the state through the CFA process. In order
- 8 to complete their application they require a
- 9 municipal letter of support from Nassau and
- 10 Suffolk counties.
- 11 LEGISLATOR SCHAEFER: Thank you.
- 12 Can you tell me how long is the -- what's the
- distance that it would be or they're hoping
- 14 for it to be from start to finish?
- MR. SALLIE: Sure. The portion
- 16 within Nassau County is roughly 12 miles. It
- would incorporate already constructed
- 18 multi-use trails through the Nassau Hub,
- 19 Eisenhower Park and then continue east through
- the central portion of Nassau County through
- 21 Bethpage State Park and then into Suffolk
- 22 County in the vicinity of Spagnoli Road and
- then continue on existing right of way in
- 24 Suffolk County all the way to the twin forks.
- 25 There are certain segments in

- 1 Planning 9-13-21
- 2 Suffolk that already exist similar to Nassau
- 3 County. So they are trying to stitch those
- 4 together.
- 5 The Trust for Public Land is very
- 6 adamant that Long Island has this amenity.
- 7 The New York State Empire Trail is on mainland
- 8 New York if you will connecting Buffalo to
- 9 Albany and then south down to just north of
- 10 New York City. Then there are trails
- interdispersed within the five boroughs.
- This is an initiative by the Trust
- for Public Land to bring that amenity here to
- 14 Long Island. So, the county has been helping
- with some of the logistics. But, again, all
- of the design work and advocacy is being done
- through the Trust for Public Land.
- 18 LEGISLATOR SCHAEFER: The grant
- 19 funds are they seeking to have it 100 percent
- 20 grant funded?
- 21 MR. SALLIE: The state program
- that they are seeking funds through is 50
- 23 percent. So 50-50.
- 24 LEGISLATOR SCHAEFER: Is there an
- anticipated amount, that 50 percent, what that

- 2 costs per county to contribute?
- MR. SALLIE: The county wouldn't
- 4 contribute.
- 5 LEGISLATOR SCHAEFER: It's Trust
- 6 for Public Land.
- 7 MR. SALLIE: Right. Trust for
- 8 Public Land funds that they raised and they
- 9 match that with state funding.
- 10 LEGISLATOR SCHAEFER: Does it
- 11 look something like you did over at Eisenhower
- 12 Park in the last few years?
- MR. SALLIE: Essentially yes.
- 14 Visually it would look the same. Ten, 12 feet
- of asphalt meandering through right of way
- 16 corridors.
- 17 LEGISLATOR SCHAEFER: Any other
- legislators have any comments?
- 19 LEGISLATOR FORD: So, is this an
- 20 uninterrupted trail or is this something where
- 21 you would have to like go off of the trail
- 22 onto like maybe county streets or something
- 23 like that? Or is it something where it's
- 24 going to be completely protected trail from
- 25 beginning to end?

- 2 MR. SALLIE: For the most part
- 3 they're looking to design it so that it's
- 4 separated from the vehicular travel way.
- 5 There is a utility corridor that's, my
- 6 understanding, it's partially owned by the MTA
- 7 partially owned by the electric utility
- 8 through the central eastern part of the county
- 9 that connects essentially up to Bethpage State
- 10 Park. There's some areas there where you'd
- 11 have to get through or pass some busy
- 12 intersections. So not completely off
- 13 separated from vehicular traffic. But for the
- 14 most part it would be a protected bike way.
- 15 LEGISLATOR FORD: Maybe small
- increments of it where you would be with the
- traffic but at a minimum basically?
- MR. SALLIE: Correct. It's an
- 19 ambitious plan. It's definitely doable.
- 20 Ultimately what it will to cost we'll need to
- 21 bring together. It's an effort.
- 22 LEGISLATOR FORD: Good effort.
- 23 LEGISLATOR SCHAEFER: Any other
- 24 legislators? Legislator Drucker.
- 25 LEGISLATOR DRUCKER: Thank you.

- I don't know if someone had asked this. Maybe
- 3 I wasn't paying attention. Sean, what's the
- 4 length of time for this project to be
- 5 completed?
- 6 MR. SALLIE: Trust for Public
- 7 Land they see this as a five to ten year
- 8 build-out for Nassau and Suffolk County.
- 9 LEGISLATOR DRUCKER: Just the
- 10 Nassau portion.
- 11 MR. SALLIE: Five years. The
- design portion is not too much of a heavy
- 13 lift. It's access to the utility, slash, MTA
- 14 corridor that could take some time. There are
- existing power lines, high tension
- transmission lines that will need to be
- 17 protected and safety is a concern. So that
- 18 needs some time to work through.
- 19 LEGISLATOR DRUCKER: They have to
- 20 design the construction would start at the
- 21 Eisenhower Park portion rather than some other
- 22 portion? It's going to start there?
- MR. SALLIE: Essentially, yes.
- 24 The trail around Eisenhower Park, the
- 25 multi-use trail ends at Carmen Avenue and then

- there's an on road bike lane that gets you a
- 3 little bit further east. So right around the
- 4 Wantagh Parkway give or take. You'd have to
- 5 get across the Wantagh Parkway and then there
- 6 is actually that straight shot utility right
- 7 of way.
- 8 LEGISLATOR SCHAEFER: Any other
- 9 legislators? Is there any public comment on
- 10 this item? There being none, all those in
- 11 favor of passing item 268-21 please signify by
- 12 saying aye. Any opposed? The item passes
- unanimously.
- Next we have clerk item 278-21,
- which is an ordinance making certain
- 16 determinations pursuant to the State
- 17 Environmental Quality Review Act and
- authorizing the grant of an easement to Long
- 19 Island Electric Utility Servco, L.L.C., as
- agent of and acting on behalf of Long Island
- Lighting Company, doing business as LIPA, over
- 22 a parcel of county-owned real property
- consisting of approximately 12,185 square feet
- 24 situated in Uniondale, Town of Hempstead,

- MR. HOMMEL: Ted Hommel from the
- 12 county attorney's office for real estate
- 13 services. This is a subsurface transmission
- 14 line. It's a request to grant an easement to
- 15 Long Island Electric Utility Services, L.L.C.,
- which is a subsidiary of PSEG, as the agent
- 17 for LIPA. The utility line runs across
- 18 property occupied by Nassau Community College
- and it's to serve the adjacent service area.
- The easement fee is based on an appraisal.
- 21 And if there are any questions of a
- 22 technical nature there are representatives
- 23 here from PSEG that will be available to
- 24 answer your questions.
- LEGISLATOR SCHAEFER: Thank you.

- 2 Does anyone have any questions on the
- 3 legislature? Is there any public comment?
- 4 There being none, all those in favor of
- 5 passing item 278-21 please signify by saying
- 6 aye. Any opposed? Item passes unanimously.

- 8 The next item we have is clerk item
- 9 279-21. It's an ordinance making certain
- determinations pursuant to the State
- 11 Environmental Quality Review Act and
- 12 authorizing the grant of an easement to Long
- 13 Island Electric Utility Servco, L.L.C., as
- 14 agent of and acting on behalf of Long Island
- 15 Lighting Company, doing business as LIPA, over

- 8 easement to Long Island Electric Utility
- 9 Servco, L.L.C. which is, again, a subsidiary
- of PSEG as the agent of LIPA. This is for
- what is called switch gear installation. 450
- 12 square feet servicing the Nassau Coliseum
- 13 surface area. It's located just south of
- 14 Charles Lindbergh Boulevard in one of the
- 15 Coliseum's parking lot. Again, the easement
- 16 fee was based on an appraisal.
- 17 LEGISLATOR SCHAEFER: Thank you.
- 18 Are there any questions from any of the
- 19 legislators? Any public comment on this
- 20 item? There being none, all those in favor of
- 21 clerk item 379-21 please signify by saying
- 22 aye. Any opposed? Item passes unanimously.
- 23 Clerk item 280-21 is an ordinance
- 24 making certain determinations pursuant to the
- 25 State Environmental Quality Review Act and

- 22 LIPA. This is, again, a switch gear
- 23 installation. This one services the new
- Nassau Police Academy on land occupied by
- Nassau Community College. Once again, the

- 4 LEGISLATOR SCHAEFER: Thank you.
- 5 Any debate or discussion by the legislators?
- 6 Any public comment on this item? There being
- 7 none, all those in favor of clerk item 280-21
- 8 please signify by saying aye. Any opposed?
- 9 The item passes unanimously. Thank you
- 10 Mr. Hommel.
- Next we have clerk item 313-21.
- 12 It's a resolution to authorize the release of
- the surety bond and escrow deposit covering
- 14 improvements on the Map of Country Pointe
- 15 Condominium I situated in Old Bethpage, Town
- of Oyster Bay, county of Nassau, New York.
- May I have a motion. So moved by
- 18 Legislator Ford. Seconded by Legislator
- 19 Drucker. I'm sorry. Seconded by Legislator
- 20 Solages. Legislator Drucker has recused
- 21 himself from this item. He has recused
- 22 himself on item 313-21, 314-21 and 315-21.
- Mr. Sallie you're here to speak on
- 24 this?
- MR. SALLIE: Yes. Good

- 2 afternoon. The three actions before you, 313,
- 3 314 and 315, are related. They are all
- 4 requests to release the bond and escrow funds
- 5 for the subdivision known as Map of Country
- 6 Point at Plainview. As the legislator
- 7 mentioned, there are three separate
- 8 applications. One is for condominium section
- 9 one. The other is for condominium section
- 10 five. And the third is for condominium
- 11 section two.
- 12 For section one the release
- requested is \$34,000 of bond and escrow
- remaining is \$41,010.09. The Nassau County
- 15 Planning Commission recommended that these
- 16 funds be released at their meeting on July
- 17 29th.
- For condominium section five the
- remaining bond to be released is \$163,683 and
- the amount of remaining escrow to be released
- is \$38,015.94. The county planning commission
- 22 also recommended release after a public
- 23 hearing on July 29, 2021.
- The last section, section two,
- remaining bond is \$70,000. Remaining escrow

- 2 is \$49,376.62. This was also recommended by
- 3 the planning commission back on July 29th.
- 4 These bonds cover the public improvements
- 5 within the subdivision. All public
- 6 improvements have been constructed to the
- 7 satisfaction of the DPW, slash, planning
- 8 commission construction inspector.
- 9 LEGISLATOR SCHAEFER: Thank you
- 10 Mr. Sallie. So, my understanding is that the
- two other items, 314 and 315, are related to
- different phases in this development. So, I'm
- 13 going to just read the items for the record so
- 14 we have that and then we can see if there's
- any debate or discussion on everything.
- 16 The next clerk item is clerk item
- 17 313-21. It's a resolution to authorize the
- 18 release of the surety bond and escrow deposit
- 19 covering improvements on the map of Country
- 20 Pointe Condominium -- I'm sorry, I just read
- 21 the wrong one.
- 22 Clerk item 314-21. Resolution to
- 23 authorize the release of the surety bond and
- escrow deposit covering improvements on the
- 25 Map of Country Pointe Condominium 5 situated

- in Old Bethpage, Town of Oyster Bay, county of
- 3 Nassau, New York.
- 4 And then clerk item 315-21 is a
- 5 resolution to authorize the release of the
- 6 surety bond and escrow deposit covering
- 7 improvements on the Map of Country
- 8 Pointe-Condominium 2 situated in Old Bethpage,
- 9 Town of Oyster Bay, county of Nassau County,
- 10 New York.
- 11 Can we have a motion for those two
- 12 items? So moved by Legislator Ford. Seconded
- 13 by Legislator Solages.
- I know you just explained those to
- us Mr. Sallie. Is there any debate or
- discussion from any of the legislators on
- these items? Is there any public comment on
- 18 these items? Didn't think so. There being
- 19 none, all those in favor of passing items
- 20 313-21, 314-21 and 315-21 please signify by
- 21 saying aye. Any opposed? These three items
- 22 pass unanimously.
