8 clerk item 282-22 which is an ordinance
9 supplemental to the annual appropriation
10 ordinance in connection with the health
11 department.

12 Can we have a motion please? By

14 Drucker. That item is before us.

15 How are you?

16 MS. DISIMONE: Anne DiSimone,
17 Health Department. This appropriation is in
18 the amount of \$5,725,000 for the Ryan White
19 program. This is 100 percent grant funded
20 through the United States Department of Health
21 and Human Services. Funding provides
22 comprehensive health and social services for
23 people living with HIV and AIDS in Nassau and
24 Suffolk counties.

25 The Ryan White program adjusts the

2 disparities in access, care and treatment for
3 racial, ethnic and socioeconomic minorities.

4 This grant has been for 20 years.

5 They served 3100 clients in '21-22 and project
6 to serve 3,276 in fiscal year '22-23. Thank
7 you.

8 LEGISLATOR WALKER: Any questions
9 or comments from the legislators? Any public
10 comment? Hearing none, all those in favor of
11 clerk item 282-22 signify by saying aye. Any
12 opposed? This will move on to Finance.
