May I have a motion?

LEGISLATOR WALKER: So moved.

CHAIRMAN KENNEDY: Move by

Legislator Walker, seconded by Legislator Gaylor.

Okay. The item is before us.

In November 2019, New York State enacted County law 226-C, which authorizes the Nassau County Legislature to waive fees to any post or hall owned by a not for profit congressionally chartered veterans organization located

/

within its jurisdiction.

The proposed resolution implements
this fee waiver pursuant to state law.
The fees waived are those charged by the
County, including but not those charged
by the Department of Public Works and the
Nassau County Police Department. Fees
charged by towns, villages and cities are
not waived pursuant to this resolution.

Further, the proposed item requires the County to refund all fees received on or after November 11th, 2019, upon application by a veterans organization within 60 days of the application.

American Legions and VFW, which qualify for fee waivers, provide integral services to our veterans and their families and they've suffered tremendous financial losses as a result of the COVID 19 pandemic.

So the goal of this proposed resolution is to provide some relief in the event that qualifying entities wish to improve their properties.
