While Darcy's coming up, I wanted to recognize and welcome, we have two council members from the City of Long Beach, I know they are here for specific items. We will call you when when that's called. Elizabeth Triston and John Bendo. Welcome.

COMMISSIONER BELYEA: First item is 180-23, Cornell Cooperative extension.

CHAIRMAN NICOLLELO: Actually, the first one we had was E74 with Brian Rosenberg. Actually there's two with E74 and E76.

COMMISSIONER BELYEA: Sorry about that.

E74-23 is a personal services agreement with Brian Rosenberg, New York. Parks conducted seeking entertainment promoters and booking agents. Nine proposals were received and evaluated. This is one of six

proposals to be awarded, as some vendors specialized in genres that others do not.

The terms of this agreement is for three years, commencing June 13th, 2023 through June 12th 2026, with the option to renew for two one-year periods. Payment on this contract will not exceed \$400,000 per year, with the total potential value of the contract not to exceed two million dollars over the potential five-year term. And funding for this contract will be from the hotel motel tax grant fund.

I just want to clarify that we do not intend to use that money every year. We just want the ability to be able to in case we have a larger ticket item act.

CHAIRMAN NICOLLELO: Okay. My question actually relates to that. I think the prior vendor was paid \$75,000 a year and then up to \$100,000 a year last year. Why the sizable jump from

So we're making it the responsibility of these contract holders to do soup to nuts.

Payment on this contract will not exceed \$150,000 per year, with the total potential value of the contract not to exceed \$750,000 over the potential five-year term. This contract will be funded using the hotel /motel tax grant fund as well. The reason for this lower amount is that the genre that this company specializes in is mostly for our senior concerts. So there's not backline requirements, nor is there food or hospitality. It's mostly like the weekly shows that are, you know, \$2-5000 a week.

CHAIRMAN NICOLLELO: Legislator Schaeffer.

CHAIRWOMAN SCHAEFER: Hi, Commissioner, how are you?

COMMISSIONER BELYEA: Good, thank you.

CHAIRWOMAN SCHAEFER: When you refer to backline equipment, are you

talking about sound and lighting; things like that?

COMMISSIONER BELYEA: Backline is like extra instruments that they may not want to travel with, and these smaller groups don't have backline. For example, we have Boyz to Men coming up that require a certain type of piano, certain types of organ that we have to provide.

CHAIRWOMAN SCHAEFER: The criteria when you were looking for new vendors, what was it; other than being able to supply all that? Was that mainly the bulk of why you were looking for different vendors?

COMMISSIONER BELYEA: Truthfully, the main thrust of this was to be able to spread our wings with regard to genres. The booking agents that we have are wonderful, but they can't find us certain acts that we're looking to put together. And also the ability to be able to pay the vendors so they're not

waiting for us to pay them.

CHAIRWOMAN SCHAEFER: One other question: I know we already know how much it's going to impact the hotel/motel tax fund. Do you know if there's still sufficient funding in there?

COMMISSIONER BELYEA: Yes. And I'll be bringing before you later on today a sponsorship agreement that's going to supplement that as well.

CHAIRWOMAN SCHAEFER: Great. Thank you.

CHAIRMAN NICOLLELO: Any other questions?

Minority Abrahams and then Legislator Bynoe.

LEGISLATOR ABRAHAMS: Just a quick question Commissioner. Just to make sure I understand it correctly. There's a provision in the contract that indicates that there'll be photos with up to six county officials. Is that something we pay for?

COMMISSIONER BELYEA: No. So the sometimes don't want to have a meet and greet, or don't want any personal contact. So it's just the opportunity to have that meet and greet. So should some of you choose to attend and you want to meet the artists, some don't allow that unless it's contractible. So we put it in this contract, so any arrangements that they make for the County will include that provision.

LEGISLATOR ABRAHAMS: It just seems odd to have that in a contract.

It implies that part of the two million dollars is going towards that service.

COMMISSIONER BELYEA: Nothing goes towards that service financially. It's just we want that clause included in our contracts with the artist and since we're not booking them directly and they are, we asked for that to be in our contract. I've learned a lot about the crazy music industry through this process.

LEGISLATOR ABRAHAMS: I'm just concerned that a provision like that could have the perception of being self-serving.

COMMISSIONER BELYEA: I don't know. I can't answer that. I mean if somebody didn't want to take a picture with us, then they don't take a picture with us.

COMMISSIONER BELYEA: Right. But it's good for promotion of our series and our events and for the County as a whole that we are able to have those photos. Again, very rare does it cause a problem.

LEGISLATOR ABRAHAMS: Yeah, well,

I don't now if it created a problem

because I don't remember a provision

like that in the past. I would feel

more comfortable if the provision was

just -- I think I'm going to support

the contract. I think it's good to be

doing what you're doing in terms of

performance and promoting. I just don't

like that provision.

COMMISSIONER BELYEA: Okay. I'm sorry. I do believe it was in the current two contracts that we have now, but I have to check on that. I can let you know.

LEGISLATOR ABRAHAMS: I appreciate that.

So that's the way I feel and we haven't discussed it as a caucus, I'm not too sure how we feel the caucus, but I think that provision should be removed. Like I said before, I wholeheartedly -- we wholeheartedly support the promotion of musical events and obviously that warrants in regards to enhancing tourism. But the last thing I think we want to do is do an agreement that says they are required to take a picture with me. I just think that sends the wrong message.

CHAIRMAN NICOLLELO: In our back up we have descriptions of these various contracts. Again, 76, 68, and 69 all relate to providing mental health services to mentally disabled children and their families residing in the county. Maybe you just want to discuss briefly 72 -- and adults.

Maybe we just want to touch on 72, which is the one with respect to opioid addiction.

MS. ZAKI: Yes, these are part of the four-year term, which is \$2 million dollars each year. For the four years it's \$8 million opioid funding which will be to expand their existing services that they are under contract

with the County. CHAIRMAN NICOLLELO: Any questions with 72? (Whereupon, no verbal response.) CHAIRMAN NICOLLELO: We're good. Thank you very much. ****

CHAIRMAN NICOLLELO: The next contracts with Department of Public Works. The first one was tabled. So we guess jump right into the, I guess B5, B14 and B73. We can just discuss as they are all related.

COMMISSIONER ARNOLD: B5, B14 and 73 are all associated with the diversion of sewage at Long Beach to the By Park or the South Water Reclamation Facility.

The Department, working with the City of Long Beach, the City, was able to get a FEMA grant to pay 100% of all costs associated with this. If you remember, we came to this Body a while back with an IMA that was approved that started this whole process off.

So B5 is a construction contract for the building of the pump station to divert the sewage from Long Beach.

Three bids were received, RJ was the lowest responsible, bidder. One bid was

rejected because they failed to submit the proper bid package. RJ's bid is that \$33.4 million dollars, which is below the industry estimate, and the

MWBE is at 32.16%.

B14 is the construction contract for the force main that will connect Long Beach to Bay Park. Posillico was the sole bidder on the project that \$79.9 million which was above the engineer's estimate. The department did due diligence on the single bid and determined that it was acceptable.

This project is extremely complicated as we are are drilling the pipe through the marsh, the get from Long Beach to Bay Park. We are not doing any work and any roadways for this were actually utilizing the old easement for the outfall pipe at Reynolds channel and sludge loading dock facility. The type of work was as a very limited pool of bidders that were available to us. The MWBE on this

project is 8% and again this is fully funded by FEMA.

And then E73 is the construction management contract for both Posillico and the RJ work. Seven firms submitted proposals De Bruin had the highest technically ranked proposal and also the lowest cost proposal. As such, the Review Committee recommended De Bruin for this work at \$6.38 million dollars. The MWBE is 20.2%. This was, again, fully funded.

CHAIRMAN NICOLLELO: Thank you. Legislator Schaefer.

CHAIRWOMAN SCHAEFER: I think you answered my question. It was just why did only one vendor respond to the one that Posillico was awarded. It's just very highly technical and it's a complicated process.

COMMISSIONER ARNOLD: Yep.

CHAIRWOMAN SCHAEFER: Thank you.

CHAIRMAN NICOLLELO: Legislator

DeRiggi-Whitton.

LEGISLATOR DERIGGI-WHITTON: How are your sink holes going?

I want everybody to know, and I would like this put on the record, that we on the Barrier Island owe a debt of gratitude to the professionalism and the dedication of our Commissioner Ken Arnold. immediately responded once the sink hole happened and it was actually a local fire department that saw something funky in the roadway, called the Town of Hempstead. They in turn called Nassau County DPW who responded immediately. Thankfully, nobody fell into this sink hole and that it was immediately closed off. Coordination with DPW, Ken was there all the time. We see DCE Arthur Walsh, who was also on top of this as well, responding to all our phone calls and everything, working with our school district. Commissioner Ryder, who dispatched the police officers to help move the traffic and they made amendments as everything was going along. I have to say that the school district and many of the residents, even though we were caught in traffic and it could be aggravating at times, everybody was just very impressed with the whole operation. We look forward to maybe

having Lido Boulevard once again fully opened up this this week, I think.

COMMISSIONER ARNOLD: Thank you.

I mean the County Executive initiating the command center was a great deal,

MR. BENDO: Good afternoon, I'm

John Bendo, I'm the president of the

Long Beach City Council. All my

comments will obviously related to this

consolidation will be for all of the

contracts.

Long Beach, we have about four and a half miles of what's been recognized as some of the best beaches in the United States. Obviously, in the summer months we are a major tourist destination for Long Island. Also, since Superstorm Sandy, Longbeach is kind of shown upon the map. People recognize now they don't have to go to the Hamptons anymore to get some great beach living, and the real estate development in our cities reflected that. Right now we have the largest construction project in all of Long

Island going on building 422 condominiums and apartments right on our beach front, in addition to other smaller projects.

But -- you know there's a but with this. We also have an extremely underutilized bay front and the reason that is we have four acres of prime bay front real estate being taken up by a 70-year old sewage treatment plant.

In addition, both Bay Park and our sewage treatment plant discharge about 200 million gallons a day of effluent into Reynolds channel, about a 100 feet off of our shore line, which has made it very difficult to develop our bay front. So you could imagine that the people of Long Beach are very anxious to see this move forward. This would probably be the largest environmental project to take place in Nassau County, probably in decades, to clean up that bay front.

You know our ocean has been

cleaned up over the last 10 years or so and we've had a return of whales, dolphins, we have seals that now show up on our beach in large numbers. We need to do the same in our bay now. The bay is still, quite frankly, a mess because of all this, effluent from the sewage plants. So this project will go a major way to closing down our plant, moving the sewage to Bay Park and then eventually from Bay Park to Cedar Creek and then out into the ocean discharge far out from Cedar Creek.

On behalf of Long Beach, we sincerely encourage you to advance this forward and let's get this done and clean up our bay, not just for Long beach, an Island Park right there with discharges are, but it's all those towns that utilize the back bay. So thank you for your time.

CHAIRMAN NICOLLELO: You can also address the Zamboni, if you would like, so you don't have to stick around.

MR. BENDO: After just telling you what what a beach town we are, we have a large ice arena in Long Beach, which is kind of unusual. There's not a lot of them on Long Island, but we have one and we are huge hockey town. We have all kinds of leagues that start with young kids that go all the way up through adults. That arena is used constantly. We've had professional players come out of that arena. The truth is, our Zamboni right now is being held together with gorilla glue and duct tape. So this is a vital piece of equipment that we need to keep our ice arena operating. And again we would very much appreciate this moving forward. Thank you.

MS. TRESTON: I just want to take the opportunity for everyone here to just tell you how thankful we are.

This is the first amendment to
the IMA between the County and the Town
of Hempstead. It's been in place since
2020 and provides for the Town of
Hempstead to provide lifeguard and
first-aid services at Nickerson Beach
Ocean Front. This amendment will allow
the Town of Hempstead to again provide
lifeguard and first-aid services at the
two pools at Nickerson Beach Park. The
term remains in the initial 2021
four-year renewal period and will

expire on September 10, 2024. The cost to the County will not exceed \$474,192 per year and will be paid out of the general fund. The County's vender that operates Nickerson Beach for us now will reimburse the County for the portion of this total amount that applies to pool lifeguarding and first-aid approximately \$170,000, which is obviously weather dependent. This reimbursement will take place via a pending service agreement, which will come before you in July.
