We have about six bus bays there. This extension will extend the lease for nine months, with the potential for it to go up through the end of 2024. As this is going on, we're also looking to move to a potential other location in

I do know that we're looking at another alternative location. I don't know if it's late because of its vicinity. Like I said, it's a busy terminal because we use six bus bays. My understanding is there's about 18. I think there's another six used by the MTA in New York City Transit bus.

LEGISLATOR SOLAGES: Is there anyone here from the NICE Bus Corporation that could answer this question?

MR. WALSH: I don't believe so. I could have someone from DPW.

LEGISLATOR SOLAGES: Please. Because again, my constituents are suffering because NICE bus corporation, which we just passed a multi-million dollar corporation for over for seven years or

3 adequate bus service to my constituency.  
4 And Mr. Jack Khzouz promised everything  
5 under the sun when he was here, and  
6 nothing has been done. And every day
