18 Item 46-24 is a supplemental  
19 appropriation in the amount of \$302,000  
20 for the Immunization Action Plan Grant.  
21 This is year two of a five year grant  
22 funded through the New York State  
23 Department of Health. This grant  
24 promotes the importance of immunizations  
25 for all ages and staff work with

healthcare providers to improve  
immunization coverage rates.
