Narrative

Purpose: To award and execute a purchase order between the Nassau County Department of Public Works and 3-GIS LLC. for the Nassau County Traffic Management On-Street Fiber Optic Network.

Discussion: This is a sole source purchase. The current system of managing fiber locations and space information is no longer adequate for the network of this size and which is expected to expand. 3-GIS LLC. is a third party software provider which will provide an accurate and efficient means of managing the County's fiber optic infrastructure.

Impact on Funding/Term: The maximum amount authorized under this purchase order shall be Two Hundred Forty Six Thousand One Hundred Seventy Dollars (\$246,170.00) from general fund PWCAPCAP 00004

Recommendation: Department of Shared Services, Office of Purchasing recommends awarding a sole source purchase order to 3-GIS LLC.



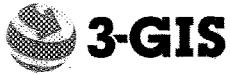

SUBJECT: Sole-Source Purchase Request – STS 12111

The Department of Public Works is requesting approval for the sole-source software purchase to manage the County's Traffic fiber optic communications network. Traffic's fiber optic network has grown larger than can be managed without the assistance of an electronic system. The available software packages are sold as Software as a Service (SaaS) and designed for the telecommunications industry.

Most of the off-the-shelf products we looked at were comparable, and for the most part achieved the same goal of fiber management. However, of the vendors we looked at, 3-GIS was determined to best meet the County's needs for the following reasons:

1. Most products are exclusively designed for the management and tracking of Fiber Optic cable, while the 3-GIS product will also allow us to manage our legacy twisted pair copper communications cable as well.
2. Compatibility and interoperability with the County's existing GIS system for easy bi-directional information sharing.
3. Since 3-GIS is an ESRI Gold Partner, we will not be subject to additional annual service charges for ESRI licenses.
4. Lastly, the 3-GIS geographical user interface works best with Traffic's existing fiber optic network design and would require the least number of staff hours to implement and maintain annually.


