NOTICE TO ALL PROSPECTIVE BIDDERS AND PURCHASERS

Article 18 of the General Municipal Law of the State of New York, Section 2202 of the County Government Law of Nassau County, also known as the Nassau County Charter, and Section 22-4.2 of the Nassau County Administrative Code, prohibits Nassau County officers, employees or agents of the County, whether paid or unpaid, or being such by election, appointment or contract, from being directly or indirectly interested in a private capacity in any business dealings with the County or any of its agencies. A County officer or employee or agent of the County, his or her spouse, minor children and dependents, a firm in which such County officer or employee or agent of the County is an officer or employee, or a corporation in which stock is owned or controlled directly or indirectly by such officer or employee or agent of the County, may not, therefore bid for or seek to purchase any of the articles, commodities or property offered hereunder.

The Office of the District Attorney reserves the right to refuse to sell property at this auction to any individual to whom these prohibitions apply, as the result of current employment or employment terminating less than two (2) years prior to date of sale, or to any individual from whom property has been forfeited, their family, representatives or anyone acting on their behalf.

The vehicles were used in the commission of felony crimes in Nassau County New York and as a result, were forfeited to the Nassau County District Attorney's Office pursuant to New York CPLR Article 13A and are sold as is, where is. The persons who forfeited the vehicles to the Nassau County District Attorney's Office are not eligible to purchase the vehicle forfeited by them from this auction.
