The Office of the Nassau County Executive often is in receipt of confidential and classified matters pertaining to public safety. The Deputy County Executive for Public Safety would be charged with supervising various sensitive matters.

The Deputy County Executive for Public Safety would explore and develop controls over excess overtime and conduct investigations into police conduct. This would include possible reorganization of the department's utilization of personnel and chain of command, and develop new contract negotiation items to assure effective delivery of vital public services.

This position will establish and maintain effective working relationships with the District Attorney's Office, Towns and Villages, FBI and other law enforcement agencies, police departments and contingent counties. The position must have a high level of security clearance, providing confidential advice to the County Executive on issues such as gang related problems, the heroin epidemic, emergency preparedness and potential terror activities.

The position of Deputy County Executive for Public Safety serves at the pleasure of the County Executive. The position will work a schedule set forth by the County Executive that often includes evenings and weekends. Must be able to supervise and guide department heads in the operations of their departments and to provide administrative oversight including the ability to review budgets and expenditures, analyze staffing levels, and provide written detailed reports to the County Executive and the Chief Deputy County Executive. Applicant must have excellent public speaking abilities as you may be required to speak before public lawmaking bodies such as the Nassau County Legislature and other public speaking engagements. Applicant must be able to work collaboratively with Union Leaders and employees covered by multiple collective bargaining agreements and become familiar with union contracts.

Successful applicants must have:

- Bachelor's Degree and
- Minimum requirement of 15 years' experience in a Police Department as a sworn
 officer in the State of New York as defined by Section 1.20 (34) of the New York
 Criminal Procedure Law with emphasis on criminal investigations, thorough knowledge
 of criminal investigative techniques, supervising and managing multiple criminal

investigations, and experience and responsibilities for staff reduction and overtime reduction in a law enforcement agency. At least 7 of the 15 year minimum requirement must have been supervising a unionized law enforcement unit both operationally and administratively.

Note: Experience as outlined above, in excess of the 15 years requirement may be substituted for college education on a year for year basis.

• Possess high level security clearance in a Police Department as a sworn officer as defined above for a minimum of at least 10 years.

Only those individuals who would **NOT** require a New York State Section 211 pension waiver will be considered.
