Mental Health Services in Nassau County have improved over the past year due to several new initiatives: 1. Integration of the Adult and Children's Mobile Crisis Team.

· Expanded hours for the Mobile Crisis Team

2. Funding and implementation of Crisis housing as a diversion to hospitalization and/or incarceration. Police at a call can identify such an individual who is then assessed by the Mobile Crisis Team, and if cleared are transported to New Hope, an OASAS funded 28 day program. It is medically supervised. There is a Nurse Practioner and Social Worker on staff. Individuals must have a co-occurring disorder.

3. Full staffing and implementation of the Mobile Residential Support Teams to provide support for individuals in Supported housing.

4. As of July 1 Central Nassau Guidance Center will become a Certified Community Behavioral Health Clinic providing the following:

- 24 hour crisis services
- · Targeted case management
- 3 crisis stabilization beds
- · Psychiatric rehabilitation services outside of PROS
- · Peer support and counseling
- Specialized services to veterans. Note all staff have been credentialed and there is a cooperative agreement with Northport VA

- · We have expanded our capacity to provide behavioral health case management services in criminal court.
- The number of NARCAN trainings provided continues to increase.

2a. Housing - Background Information

The Nassau County Residential Program Indicators reflect high occupancy percentages in the behavioral health housing programs, therefore, housing efforts continue to be an important priority for clients in Nassau County. According to the LI DISRIP Needs Assessment, the number of beds for Family Care is 254, Congregate Treament is 1,137, Apartment Treatment is 395 and Supportive Housing beds at 2,447. Most beds are located in Suffolk County. Over 500 individuals with a serious mental illness are on the SPA waiting list for housing in Nassau. Many of these individuals are discharged into the community from inpatient psychiatric units or are homeless and therefore, not eligible for the supported housing beds. Recently Turquoise House (Mental Health Association), a 3 bed peer run house to provide hospital diversion, when appropriate.

Over the past couple of years, SAIL was expanded to provide housing for individuals with a substance use disorder or co-occurring mental health disorders. There is a great need for additional housing resources for people with substance use disorders.

2b. Transportation - Background Information

The LGU submitted a grant proposal seeking funds to provide improved and expanded transportation services for adults with developmental disabilities in Nassau County and was awarded a \$357,000.00 grant from the Federal Transportation Administration/New York State Department of Transportation. Our Office partnered with Rides Unlimited, Inc., to implement a transportation program for clients of Family Residences and Essential Enterprises (FREE) and The Rehabilitation Institute (TRI). Consistent with the grant application, the task of convening a Stakeholder Transportation Advisory Committee, consisting of representatives from Rides Unlimited of Nassau & Suffolk, NYS Office for People With Developmental Disabilities, intellectual/developmental disability provider agencies, representatives from the target population, family, and advocacy groups was achieved. The The Call Center began operating June 2015 and the "Mobilizing Nassau" program began transportation services to I/DD adults in November 2015.

Mobilizing Nassau will terminate on 09/30/2017, the last day of operations for the three year grant. The passenger targets that were identified by the co-lead on the project (FREE) were not met. A key lesson learned throughour the grant period is that we need a "on demand taxi" service for those who require assistance with getting to social or work situations.

An analysis and identification of "lessons learned" revealed the following:

A. Rides Unlimited was not able to meet the passenger route requests due to a shortage of CDL drivers. This shortage is not specific to Unlimited but has in fact

been written about in the print media. Unlimited was not able to accommodate requests for destinations past a certain range nor were they able to accommodate requests for evenings and weekends.

B. The mobility manager for *Mobilizing Nassau* was tireless in her promotion of the program and exhausted all avenues of promotion for utilization of same. An unforeseen clinical finding is that parents of young and not so young adults with intellectual and developmental disabilities appeared reluctant to put their adult children "on a bus" to transport them to activities.

C. Concurrent with the implementation of Mobilizing Nassau New York State Office for People With Developmental Disabilities there was a 700% increase in the number of self-directed plans in Nassau County. This essentially meant that ID/DD clients can, and do hire support workers to drive them to activities, something parents feel much more comfortable with.

2c. Crisis Services - Background Information

The Mobile Crisis Services have been expanded to include an additional crisis team. The hours were extended through the partnership between NYS OMH staff and staff of EPIC, a mental health contract provider. The efforts of the mobile crisis teams have doubled in the last year to about 100 site visits in the community. The accessibility of the mobile crisis teams has increased through our 227-TALK helpline.

2f. Prevention - Background Information

Based on the Nassau County ME report, the Heroin/Rx Drug epidemic has shown an increase in overdose deaths in Nassau County, rising from 52 in 2004 to 149 in 2014. Deaths have continued to rise with 177 in 2015 and 190 in 2016. Monthly meetings with our funded prevention network and participation on various Nassau County coalitions show that no community is immuned to the effects of addiction and some, grant recipient Massapequa, have been dealing with high levels of opioid abuse and deaths, with survey statistics showing 60% of young adults reported it was easy to obtain Heroin and 85.7% were able to obtain Rx drugs not prescribed to them at home.

When an individual is in pain, opioids function appropriately by attaching to the opioid receptors in the brain, spinal cord and other organ nerve endings, thus providing relief from the perception ofpain. When the body is no longer in pain, brain chemistry is changed by the opioid medication. Repeated use or abuse of opioids inhibits the body's own production of opioid chemicals such as endorphins and thereby increases the discomfort felt when no longer ingesting opioid medication. Misuse and/or abuse of opioids including heroin has strong effects on the brain's reward system, leading to a euphoric high, one that an individual will then seek to achieve on a regular basis. The drug activates a major property of repeated opioid use-tolerance-leading to increased dosages to achieve the desired effect. Tolerance is developed through the opioids ability to diminish the brain's natural opioid system, decreasing natural response over time. For those that have been recently detoxed, tolerance can be a major factor in overdosing, as an individual will take a higher dosage although no longer having the same level of tolerance.

We all know this is a complex issue that involves needed support at all systems levels such as local government units, pharmaceutical industries, communities, medical insurance carriers, law enforcement, community based treatment programs, prevention programs and families.

The Assessment and Referral Center (ARC), co-located with the local Department of Social Services (DSS) continues to interact with citizens seeking services at DSS. Over 200 citizens are interviewed per month and their needs for health home services, outreach and care coordination are assessed to assist them with their daily living needs. Given that the ARC encounters many individuals who are falling through the cracks of the health care system, the plan is to gain MH clinic licensure for the program.

The Office's crisis helpline, 227-TALK continues to operate at high capacity. ARC clinicians provide chemical dependency and mental health prevention, intervention and treatment referral information to citizens seeking help for themselves, their families and significant others. The 227-TALK program responds to over 6,000 calls annually. Of note.

The AOT clinical review team, including the AOT psychiatrist, review and approve treatment plans prior to this Office bringing forth a petition. We also review the plan when providing a letter of designation to the psychiatrist at Pilgrim Psychiatric Center or a community hospital inpatient unit, when they are making the AOT petition to the court. Each AOT client in the investigation phase, active phase or as a step down to a voluntary treatment agreement is assigned to an AOT coordinator in our Office, and that coordinator monitors compliance with treatment, or any requests for changes in treatment.
