2021-2022 ARC CALENDAR

Jan. 2, 2020 - Assessor publishes tentative assessment roll based on value as of this date.

Jan. 2, 2020 - March 2, 2020 - ARC filing period.

March 2, 2020 - Last day to appeal 2021-22 assessment published on January 2, 2020 roll.

March 3, 2020 - March 31, 2021 - ARC reviews 2021-22 appeals and makes determinations.

March 31,2021 - ARC sends out final determination letters for 2021-22 grievances.

April 1, 2021 - Department of Assessment publishes final assessment roll reflecting changes made by ARC and exemption changes for 2021-22.


April 30, 2021 - Last day to file for judicial review of final assessment for 2021-22.

ASSESSMENT REVIEW COMMISSION

ARC, the Assessment Review Commission, is an independent agency, separate from the Department of Assessment.

We are responsible for annually reviewing all applications for correction of property tax assessments filed in Nassau County.

Filing period is:

January 2, 2020 - March 2, 2020

DEADLINE EXTENDED TO APRIL 2, 2020

This application is to appeal the tentative assessment set by the Department of Assessment on January 2, 2020.

Filing this application will affect your October of 2021 School tax bill and January 2022 General tax bill.

You may file an application every year.

Applications can be filed to appeal exemptions, class change and value.
