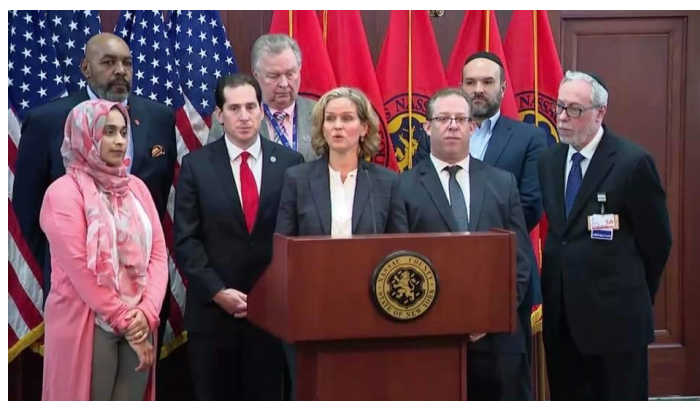

## Information on Small Business Loans

Our office recognizes the financial toll this pandemic has caused on small business owners. In response, we are regularly updating our constituents on federal and state economic relief opportunities, such as the Economic Injury Disaster Loan (EIDL) or the Payment Protection Program (PPP).

EIDL provides loans of up to \$2 million dollars to help overcome the temporary loss of revenue due to the coronavirus. PPP is a forgivable loan that incentivizes small business owners to retain their workforce and rehire laid-off workers.
