Nassau County Community Food Distributions

In response to the increased demand for food caused by the COVID-19 pandemic, County Executive Laura Curran has allocated \$1 million dollars to address food insecurity. The County program partners with Long Island's two major food banks, Island Harvest and LI Cares, to distribute food at dozens of Community Food Distribution sites across the County. To date, these efforts have provided food assistance to over 13,000 struggling families.

The Office of Asian American Affairs (OAAA) has participated in many of the food distributions and coordinated 75 volunteers to join the team at the Valley Stream and Hicksville locations. Volunteers from Asian-American organizations helped package food supplies for families in need. We are grateful for their time and effort!

OAAA also arranged for several Asian nonprofits to distribute County-purchased food supplies to people in need who were unable to come to the site.

"No one in our County should have to worry about where their family's next meal is coming from," said Nassau County Executive during one of the many food events. "Nassau County will continue to meet the surge in demand for food assistance in our communities." Partnering with the *Holocaust Memorial and Tolerance Center of Nassau County* to Promote Understanding and Tolerance

On May 18th, Nassau County Executive Laura Curran joined OAAA and the *Holocaust Memorial and Tolerance Center of Nassau County* for a webinar to raise awareness of discriminatory behaviors and reporting methods entitled "Combating Hate as We Combat COVID-19: The Response in the Local Jewish and Chinese Communities."

Other cosponsors included the Chinese American Association of North Hempstead (CAANH), the Long Island Chinese American Association (LICAA), the Jewish Community Relations Council of Long Island (JCRC-LI), and the American Jewish Committee Long Island Region (AJC).

Such conversations are critically important as we work to ensure all our residents feel welcome and safe in Nassau. Since the outbreak of COVID-19, our office has received many anecdotal reports of discrimination against members of our Asian community, such as non-Asians intentionally avoiding Asians in public and a decline in patronage at Asian-owned businesses.

While OAAA has not received any reports of overt or violent incidents, we want to ensure that our constituents are well protected and informed.

Small Businesses

Nassau County Executive Laura Curran, in partnership with the Nassau County Local Economic Assistance Corporation (LEAC), the sister agency of the NC Industrial Development Agency (IDA), rolled out a new "Boost Nassau" program to assist small businesses and non-profits organizations hit hard by the pandemic. The program consists of two main initiatives: a Free PPE Kit Giveaway and a low-interest loan program.

OAAA has played a critical role in assisting Asian-owned businesses to learn about these programs and complete applications. Our staff also participated in a PPE kit distribution at Eisenhower Park in June. To date, over 1,000 PPE kits have been distributed and another 4,000 will be distributed this month. The Boost Nassau loan program is geared toward small businesses and non-profits that did not receive the PPP or EIDL from the Federal Small Business Administration.

Our office also participated in a virtual seminar hosted by the *Holocaust Memorial & Tolerance Center of Nassau County* to inform the masses of China's crimes against the Uyghur people.

The Uyghur are a Turkic-speaking Muslim minority population in western China.

In what the U.S Congressional-Executive Commission has defined as "Crimes Against Humanity," over 1 million Uyghur people have been interned in the northwestern Xinjiang province of China and are forced to undergo "reeducation" tactics. These tactics include forced labor, torture, and food deprivation--- a clear and utter violation of human rights.

Thank you to the guest speakers, Dr. Adrian Zenz, a Senior Fellow in China Studies at the Victims of Communism Memorial Foundation, and Rushan Abbas, the founder and Executive Director of Campaign for Uyghurs. Eid Drive-Through Celebration

To spread holiday cheer from a safe and social distance, Nassau County hosted its first-ever Eid Drive-Through Celebration.

County Executive Laura Curran, Police Commissioner Patrick Ryder and Legislator Arnold Drucker joined OAAA Executive Director Farah Mozawalla along with the Asian Advisory Council in the celebration!

The Nassau County Executive & Legislative Office Building's parking lot was transformed for the drivethrough event. Over 1,000 cars and 3,000 people participated, passing by stations while volunteers distributed "animal balloons," South Asian food and desserts, and even surgical masks and other personal protective equipment. A jumbotron played music and displayed pictures of community members and celebrations.

Due to the public health crisis, our office has experienced an increase in inquiries and requests for assistance on a range of issues, including domestic violence, unemployment, and food assistance.


See the graph below to see a breakdown of the 289 constituent requests and concerns we had received for the week of 06/05/2020 to 06/18/2020.

Many constituents who request OAAA assistance speak English as a second language or are English limited proficient. As such, they often do not know what government resources they may qualify for or who to turn to for support and help.

The Nassau County Office of Asian American Affairs, as an outreach department, has been working hard to reduce the language gap for accessing County services. We translate economic, social and policy updates in prominent Asian languages that we broadcast on our Facebook, Twitter, and Instagram pages and on our website. We disseminate key County documents and press releases in Urdu, Hindi, Bangla, Chinese and Arabic. We assist in the County's SMS program by translating important announcements via text messages in Hindi, Urdu and Mandarin. We also translate state policies and procedures for our constituents. Since the start of the ongoing pandemic, our office has issued about 100 Public Service Announcements.

Our familiarity and longstanding relationships with the local communities provide us with a unique platform to connect our constituents to the government resources they need.
