## Democrats Demand That Republicans Use the \$14 Million They Have to Pay Residential Refunds Now

Mangano Forced to Reverse Course after Dems School
Him on Tax Cert Refunds

(Mineola, NY) – Democrats in the Nassau County Legislature questioned why the Mangano Administration was withholding residential refunds when there is over \$14 million to pay those claims now.

Democratic Minority Leader Kevan Abrahams last week requested that the Office of Legislative Budget Review (OLBR) identify the funds available from the 2010 bonding approved by the legislature.

The OLBR report confirmed that the County has \$14.7 million available to pay assessment challenges. In 2011 the County paid \$28.6 million in commercial judgments and only \$2.3 million in residential claims. The Administration has stated that the County still owes \$20 million in residential refunds.

"We know that there is money in the bank to pay homeowners right away, but the Mangano Administration has sat on those funds for over a year and tried to force our hand into lumping \$102 million in settlements together without the ability to thoroughly review each case," said Abrahams.

Last week County Executive Ed Mangano sent a letter to over 17,000 homeowners that are owed a refund stating that the Democrats were holding up their payment. Mangano also claimed in his letter that without the Democrats approval to borrow over \$100 million he would have to raise taxes 25%. A claim without any merit since New York State passed a law in 2011 which limits property tax increases to the lesser of 2% or the rate of inflation. Mangano was present at the ceremonial bill signing of this by Governor Andrew Cuomo in Lynbrook last June.

"The fact that not only has the County Executive been sitting on millions of dollars that should be paid to county residents who are owed that money, but then also spends taxpayer dollars to a mail scare tactic letter that contains out and out lies defies all logic and reason," stated Abrahams. "It is absolutely unacceptable that the head of our government acts in such an incompetent and irresponsible manner."

While the \$14 million has been identified it is still uncertain whether the Mangano Administration will actually use it to refund homeowners.

In addition, on Friday, the Mangano Administration was forced to file an amendment to remove all tax certiorari judgments and settlements under \$100,000 for approval from the Nassau County Legislature.

Democrats objected to the process during a meeting of the Legislature's Finance Committee two weeks ago. Among the issues raised by the Democrats were that claims under \$100,000 were not subject to approval by the Legislature and that Legislators needed to have the necessary backup to review commercial cases, which the Mangano Administration had not provided at the time. County Attorney John Ciampoli asserted that the new review process was due to NIFA involvement, a claim that NIFA strongly disputed.

This pushback by legislative Democrats that resulted in the County Executive submitting the amendment is a victory for residents who have had their tax refunds held hostage by the Mangano Administration as they sought to lump all residential and commercial settlements together into a \$102 million bond.

"This amendment shows that we should never have gotten anything under \$100,000 or any of the residential refund cases", said Abrahams. "It is unbelievable that neither the Administration nor the Republican majority knew this. With moves like this they are becoming the poster children for incompetence."

Re: Assessment Challenges

As per your request, the Office of Legislative Budget Review (OLBR) has prepared a schedule detailing the tax certiorari payments by month for 2010 and 2011. OLBR has also verified the available funds in capital project (9A413) Tax Certiorari Judgments. To date, there is approximately \$14.7 million available in proceeds to fund tax certiorari judgments in capital project 9A413. The following charts detail the payments made for commercial judgments, residential small claims, petitions as well as any cancellations and reductions for 2010 and 2011. In total, the County spent \$74.2 million in 2010 and \$39.3 million in 2011. The 2010 total of \$74.2 million includes \$56.4 million spent on commercial judgments, \$6.2 million on residential small claims, \$877,356 in petitions, and \$10.7 million in cancellations. The 2011 total of \$39.3 million includes \$28.6 million in commercial judgments, \$2.3 million in residential small claims, \$1.2 million in petitions and \$7.2 million in cancellations.

### TUME SENSITIVE INFORMATION ABOUT YOUR TAX REFUND

Dear Homeowner:

I am writing you with important information regarding your property tax refund. It appears for purely partisan political reasons, nine Democrat County Legislators are threatening to shut down county government and, in doing so, to deny you the property tax refund you are owed.
