From The Executive Director



Nassau County Services for Seniors

In collaboration with the Nassau County Office for the Aging, the Office of Asian American Affairs hosted a "Services for Seniors" webinar on March 9th. County Executive Laura Curran and OFA Deputy Commissioner Jorge Martinez joined OAAA Executive Director Farah Mozawalla in the live session.


"It's really important that we reach our Asian seniors," said County Executive Laura Curran. "We want to make sure we are doing everything we can to reach those communities and let them know what is available."

Among the topics discussed were home delivered meals, senior centers, caregiver assistance, and inhome assistance program/case management.

"Data from New York City's AARP shows that the health disparities are the highest among Asian seniors compared to any other ethnicity or race," said Executive Director Farrah Mozawalla. "Based on OAAA's interactions with residents of Nassau County, senior programs have been recognized as one of the main areas of concern."

Careers in Nassau County Government

Working with the Nassau County Civil Service Commission, the Offices of Hispanic Affairs, Asian American Affairs and Minority Affairs hosted "Careers in Nassau County Government", an interactive workshop series. The three sessions took place on April 27th, May 26th and June 15th.

""Nassau County employs about 7,200 people. 7,000 of those are civil service jobs," said County Executive Laura Curran. "Our job and the job of this wonderful team that you have here is to demystify the whole civil service process. We have a goal of making sure that all of our diverse communities in Nassau County have access to this information."

Guided by the Civil Service Commission during the presentation, attendees learned more about navigating the civil service website, understanding open announcements and competitive examinations, viewing current opportunities including full-time and seasonal positions, exploring the benefits associated with full-time county employment, along with much more!

WORKING TOWARDS VACCINE EQUITY

COVID Conversations Webinar

The COVID-19 pandemic brought health inequities to the forefront of society. The County Executive has prioritized assisting underserved and marginalized communities. On March 17th, OAAA collaborated with the Department of Health's Office of Health Equity to host "COVID Conversations." This webinar focused on COVID-19, the efficacy of the vaccines, and dispelling common misinformation. Special thanks to the Director of the Office Health Equity Andrea Ault-Brutus, PHD, MPA; Liana Leung, MD, MPH, FACP; Farhana Satti, MD; Isma H. Chaudhry, MD, MPH; and Isabella Park, DO for taking the time to offer their knowledge and expertise directly with the community.

Nassau County Vaccine Equity Group

The Office of Asian American Affairs is also a part of the Nassau County Vaccine Equity Group to ensure an equitable rollout of the vaccine. This is joint taskforce between the Office of Hispanic Affairs, the Office of Minority Affairs, the Office of Asian American Affairs, the Department of Health's Office of Health Equity. and the Department of Human Services. The goal of the group is to ensure that minority communities and those especially hard-hit by Covid-19 have equal access to vaccine appointments. From January through March, in the early stages of vaccinations when supplies were low, our office contacted constituents directly and made more than 2,500 vaccine appointments for the Asian community. We will continue our efforts to keep every community informed and equipped with the resources to eliminate Covid-19 and help Nassau County come back healthier and stronger than before.



Small Business Support and Outreach

Throughout the pandemic, OAAA has conducted a campaign dedicated to connecting Asianowned small businesses with County resources and programs. Our staff has visited businesses in Hicksville, Elmont, East Meadow, Levittown, Bethpage, Westbury, and Valley Stream with further plans to reach more areas in Nassau County. Through this outreach initiative, we have raised awareness on the importance of getting vaccinated, our office's services, and most recently Nassau County's Boost Nassau Resource Center, which serves as a one-stop-shop for COVID recovery resources and information. The Resource Center is both an online portal and an in-person hub where constituents can choose to visit by appointment. ENSURING FOOD SECURITY

Food Distributions

Following the County's commitment to addressing food insecurity, which provided food to over 35,000 families through 2020, OAAA took additional steps to support food distributions from February through April of this year. In collaboration with Island Harvest and Masjid Al-Baqi, we distributed hundreds of grocery items each week to local relief and community organizations that then distributed these items to vulnerable communities. Working through these organizations' expansive networks, Nassau County was able to take active measures in combating food insecurity.

COMBATTING HATE

Interfaith Candlelight Vigil

On April 1st, Nassau County Executive Laura Curran, the Office of Asian American Affairs and a diverse group of organizations hosted an Interfaith Candlelight Vigil Against All Acts of Hate and Discrimination on the front steps of the Theodore Roosevelt Executive and Legislative Building. The vigil was held in honor of the victims of the Georgia massage parlor shootings, which took the lives of eight people, six of whom were women of Asian descent.

Hundreds of community members gathered to demand an end to a surge of anti-Asian racism and violence.

"Nassau County is standing together against the rising tide of Anti-Asian hatred. Although there have been no reported hate crimes targeting Asians in Nassau, the attacks we're seeing nationwide are unacceptable. Nassau County will continue

Business Resource Webinar for the AAPI Community




