In early January, two of the deadliest residential fires of the past 40 years in the US happened just days apart in Philadelphia and the Bronx.

A total of 29 people died, including more than a dozen children.

Home Fire Safety and Prevention

Home Fire Safety and Prevention

The tragic fires in New York and Philadelphia have brought a renewed focus on fire safety. While fire deaths have declined over the decades, the National Fire Protection Association (NFPA) estimates 3,000 yearly deaths from residential fires persist. One reality of the present age is the higher presence of more flammable material in electronics, making fires easier to spread in a home. As such, preparedness and prevention measures are necessary to prepare a home for a fire emergency. The fire department tries to arrive in six minutes, a crucial amount of time on your own to act in the event of a home fire.

Have and practice twice a year an evacuation plan with your household. Be aware of two ways to escape, whether a stairwell or alternate door to outside. However, if no safe exit exists, shelter in place may happen depending on the type of building, as residents did in the Bronx fire. Whether in a high-rise building or a single home, one's evacuation plan can make a difference in survival. Teach children what alarms do and ensure everyone knows how to call 9-1-1. In addition, an emergency communication plan is critical to reuniting the family after an emergency. As the Red Cross suggests, everyone should know who to contact to help rally members.

Test smoke alarms monthly and replace batteries once a year. In addition, know their expiration dates to replace them every ten years. If in public housing or an apartment, contact customer service with any issues with your alarms. For alarms to do their jobs, take them seriously. Survivors of the January fires reported frequent false alerts had normalized them to ignore alarms, which cannot happen with fire safety. By the time the danger is obvious, it may be too late. Be aware of the limitations of your building. For example, older apartment buildings may be held to different regulations in having sprinkler and other preventative systems. Having such knowledge will help you know what can and can not happen in a fire!

Apply preventative measures to household items. For example, keep potential fuel for fires at least three feet from stoves, fireplaces, or heaters. Put space heaters on even and nonflammable areas.

Unfortunately, many of the victims were youth and one of the fires began with a child playing with a lighter. Put fire-starting items out of children's reach and consider flameless candles to prevent accidents. Fire safety for children is important for their present safety and to ingrain habits to carry into adulthood. One way to teach children ages 4 through 8 is via the Red Cross's Pedro's Fire Safety Challenge, available through Alexa or Google Assistant-enabled devices.

Home fires can happen to anyone, but year-round preparation is the best way to protect your and your loved one's safety.




Install smoke alarms on every level of your home, inside bedrooms and outside sleeping areas.


Activity Summary:

The purpose of this test was to determine the communications capabilities of CERT members during an actual emergency. CERT, ARES, RACES and BTG members were to attempt making contact with other members using FRS Radio Channels 4 or 5. Licensed Amateur Radio and GMRS operators where asked to assist in relaying any CERT members they heard via their respective frequencies set fourth in the communication plan for this test.

Major Strengths:

Despite the repetitively short notice and technical issues this test helped to define what issues we need to focus on for interoperability between the communication modes

Those individuals participating in this test adapted to the unforeseen issues

Returning to actual in person trainings will help enhance members abilities to respond to emergencies

Areas for Improvement:

More advance planning, advertising and coordination may have yielded a better result

It was unclear if those participating understood the primary objective was to test FRS communications

Some GMRS operators where not clear or didn't understand how to transmit without tones

Technical issues with the BTG repeater didn't allow for the instructions or message to be disseminated over the repeater as originally planned

Suggested Planning Activities:

Review and familiarize the CERT members with the CERT Communication Plan at division meetings

Division leaders to Poll their CERT members to see who has their own FRS Radio

Create a map to include all members with radio capabilities (FRS, GMRS, Amateur Radio)

Schedule a follow-up emergency radio exercise

Better coordinate efforts with Amateur radio and GMRS groups as to the role they play in the CERT Communication Plan

Suggested Operational Activities:

Conduct an FRS communications training with live exercise at CERT division meetings to re-enforce radio fundamental skills

Continue ICS forms trainings in both virtual and face to face CERT meetings
