**PROPOSED ORDINANCE NO. - 2025**

**AN ORDINANCE AMENDING ORDINANCE NO. 180-2016-AN ORDINANCE ESTABLISHING A FEE SCHEDULE FOR COUNTY SERVICES FOR VARIOUS COUNTY DEPARTMENTS**

**APPROVED AS TO FORM**  
  
**MINORITY COUNSEL**

WHEREAS, pursuant to section 10(1)(ii)(9-a) of the Municipal Home Rule Law, the County of Nassau has the power to adopt and amend local laws relating to the fixing, levy, collection, and administration of charges, rates, and fees; and

WHEREAS, small businesses are a vital part of Nassau County's economy providing essential goods and services, creating jobs and contributing to the vibrancy of our communities; and

WHEREAS, burdensome licensing fees can disproportionately impact smaller business owners who often live and work in Nassau County and may have limited resources, especially minority-owned, women-owned, veteran-owned and startup businesses; and

WHEREAS, licensing often serves as an important role to protect the consumers, but reducing the cost of said licensing can achieve the same desirable outcome while also encouraging economic growth; and

WHEREAS, the Nassau County Legislature finds it is in the best interest of the County's business and its residents to reduce the licenses fees; now therefore

BE IT ORDAINED by the County Legislature of the County of Nassau as follows:

Section 1. Section 2 of Ordinance No. 180-16, is hereby amended to reduce the current license fees as follows:

§2. The following fees are fixed for the Office of Consumer Affairs, **and previous fees set forth by this section in Ordinance No. 180-16 are no longer valid** [for the following years:]. Reference is made to the provisions of the Nassau County Administrative Code relevant to a particular fee.

Section 2. It is hereby determined, pursuant to the provisions of the State Environmental Quality Review Act, 8 N.Y.E.C.L. section 0101 et seq. and its implementing regulations, Part 617 of 6 N.Y.C.R.R., and Section 1611 of the County Government Law of Nassau County, that the adoption of this Ordinance is a "Type II" Action within the meaning of Section 617.5(c)(26)

and (33), and, accordingly, is of a class of actions which do not have a significant effect on the environment; and no further review is required.

Section 3. This ordinance shall take effect immediately.
