2027-28 ARC CALENDAR

Jan. 2, 2026 - Assessor publishes 2027/28 tentative assessment roll based on value as of this date.

Jan. 2, 2026 - March 2, 2026 - ARC filing period to appeal the 2027/28 assessment.

March 2, 2026 - Last day to appeal 2027-28 assessment published on January 2, 2026 roll.

March 3, 2026 - March 31, 2027 - ARC reviews 2027-28 appeals and makes determinations.

March 31, 2027 - ARC sends out final determination letters for 2027-28 grievances.

April 1, 2027 - Department of Assessment publishes final assessment roll reflecting valuation and exemption changes made by ARC for 2027-28.

April 30, 2027 - Last day to file for judicial review of final assessment for 2027-28.

Please note that the deadline for filing an appeal has been extended to March 31, 2026

ASSESSMENT REVIEW COMMISSION

ARC, the Assessment Review Commission, is an independent agency, separate from the Department of Assessment.

We are responsible for annually reviewing all applications for correction of property tax assessments filed in Nassau County.

The 2027/28 filing period is:

January 2, 2026 - March 2, 2026

DEADLINE EXTENDED TO MARCH 31, 2026

This application is to appeal the 2027/28 tentative assessment set by the Department of Assessment on January 2, 2026.

Filing this application will affect your October 2027 School tax bill and your January 2028 General tax bill.

You may file an application every year.

Applications can be filed to appeal exemptions, tax class and value.
