Instructions

Authorization for exemption

Real Property Tax Law § 466-a authorizes the governing body of a county, city, town, village, school district, or fire district, to partially exempt up to 10% of the assessed value of the residence of a volunteer firefighter or ambulance worker, and up to 50% of the assessed value of the residence of the surviving spouse of a volunteer firefighter or ambulance worker killed in the line of duty. The exemption does not apply to special assessments.

An eligible city, village, town, school district, fire district, or county may enact, after a public hearing, a local law, or a resolution in the case of a school district, to adopt the volunteer firefighters/ambulance workers exemption. Consult your assessor to ascertain whether the exemption is available locally.

Eligible owners/applicants

The exemption applies to real property owned by an eligible applicant, as well as real property held in a trust solely for the benefit of the applicant if the applicant would otherwise be eligible for the exemption. If the title to the property is in more than one name, list each name in the applicant box. If the property is held in trust, answer all the questions based on the beneficiary's qualifications for the exemption.

Municipalities that offer the exemption may also offer it to otherwise qualifying volunteer firefighters or volunteer ambulance workers who are tenant-stockholders of a cooperative apartment corporation. The exemption will apply to the portion of the assessed value of the real property owned by the cooperative apartment corporation that is deemed to be vested in the tenant-stockholder. The resulting real property tax savings to which the tenant stockholder is entitled will be credited by the cooperative apartment corporation against the taxes otherwise chargeable to the tenant stockholder.

A tenant-stockholder is not eligible for an exemption if they reside in a dwelling subject to the following provisions of the Private Housing Finance Law:

- a limited-profit housing company,
- a limited dividend housing company,
- a redevelopment company, or
- a housing development fund company.

Note: If you receive this exemption, you **cannot claim** a New York State income tax credit for the same volunteer service. However, if the property has multiple owners, the owner(s) whose volunteer service was not the basis of the exemption are eligible to claim that credit.

Member eligibility

The exemption is available only to members of incorporated volunteer fire companies, fire departments, or incorporated ambulance services who have been certified as being enrolled members for a minimum of two to five years, depending on the policy. The municipality determines the procedure for certification.

At local option of the city, town, village, school district, fire district, or county, an enrolled member who has accrued more than 20 years of active service may be granted a 10% exemption for the remainder of their life, if the member's primary residence is located within such county.

Surviving spouse eligibility

At local option, the exemption may be continued or reinstated for the surviving spouse of an enrolled member killed in the line of duty who had been a member of the volunteer fire company, fire department, or volunteer ambulance service for a minimum of two to five years and was receiving the exemption prior to their death.

At local option, the exemption may be continued or reinstated for the surviving spouse of an enrolled member who accrued at least 20 years of active service and was receiving the exemption prior to their death.

Residency requirement

The exemption may be granted only to applicants who reside in the city, town, or village served by the fire company, fire department, or ambulance service. At local option, municipalities may also offer the exemption to applicants who serve a neighboring city, village, town, county, or school district.

The exemption is only available for the applicant's primary residence and only to property (or the portion thereof) exclusively used for residential purposes.

Deadline

The deadline for 2027-2028 exemption applications in Nassau County is January 4, 2027.

Once the exemption is granted, the exemption may continue for the authorized period provided that the eligibility requirements continue to be satisfied. It is not necessary to reapply after the initial year for the exemption for it to continue.
