FY 12 Sales Tax

Year-to-date sales tax collections total \$826.2 million. This is an increase of \$39.1 million, or 5.0%, over the receipts through the same period last year.

Sales Tax Receipts

To attain the Office of Management and Budget's current projection, only a 1.04% growth over the remainder of the year is required. Based on year to date collections, the 2012 budget will be exceeded.

According to MasterCard Advisors' SpendingPulse data, Superstorm Sandy decreased retail sales in the Mid-Atlantic and Northeastern Regions by nearly \$4.0 billion or 20% of the weekly historical total. According to the December 31, 2011 Nassau County Comprehensive Annual Financial Report, in 2010, retail trade sales constituted 53.14% of total Nassau County taxable sales.

There are different views on the net economic impact of Superstorm Sandy.

According to New York State Comptroller DiNapoli, the rebuilding effort may offset some of the initial losses.² However, Moody's Analytics opines that the two forces completely offset each other and the storm has no noticeable impact on the national economic data.³ Others opine that the storm will have a net positive impact on the economy. According to John Silvia, chief economist for Wells Fargo Securities, there will be a slight lift from the storm to the national economy.⁴ Given the magnitude of the recent storm, OLBR will be closely monitoring any shifts in sales tax collections.
